IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1 CONTRACT NO. 21-667 CUSTODIAL SERVICES CONTRACT

The following is an amendment to Contract No. 21-667 between RNA of Ann Arbor Inc. dba RNA Facilities Management (hereinafter "Contractor") and San Bernardino County (hereinafter "County") for custodial services on the premises located at:

- Multiple County Locations – Attachment B

The complete Contract includes all of the Contract Documents, to wit:

- CONTRACTOR'S proposal dated May 19, 2021 (referenced but not attached)
- Scope of Work (Attachment "A") (referenced but not attached)
- Cost Per Site (Attachment "B")

And they are included in their entirety as a part of this Contract by reference thereto.

WHEREAS, the County conducted a competitive process to find RNA of Ann Arbor dba RNA Facilities Management (Contractor) to provide custodial maintenance services (Services), and

WHEREAS, based upon and in reliance on the representations of Contractor in its response to the County's Request for Proposals, the County found Contractor qualified to provide these Services; and

WHEREAS, the County desired that such Services be provided by Contractor and Contractor agreed to perform these services as set forth below; and

WHEREAS, on 9-14-21 (Item No. 45), the Board of Supervisors approved Contract No. 21-667 for these Services; and

NOW, THEREFORE, the County and Contractor mutually agree to the following terms and conditions:

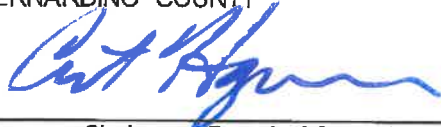
1. **REPLACE Section F.1 FISCAL PROVISIONS**, with the following: The County will compensate CONTRACTOR for its services under this Contract the total amount of \$90,723 dollars per month (effective 4/1/22), one month in arrears. **In addition, during the declared State of Emergency, County will compensate CONTRACTOR for additional COVID-19 related services, if such services are requested by the County in writing (not to exceed \$650,000). CONTRACTOR acknowledges the COVID-19 related services shall be on an on-call basis and there is no guarantee of a minimum amount of work that will be assigned to CONTRACTOR.** CONTRACTOR will only be compensated for COVID-19 related work performed following receipt of written or email authorization from the Project & Facilities Management Department, approving the work and the estimate provided by Contractor. CONTRACTOR shall include the written or email authorization with any email provided by contractor. The maximum amount of payment under this CONTRACTOR shall not exceed \$6,015,130 dollars. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.
2. **CONTRACT EXECUTION**
This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
3. **REPLACE ATTACHMENT B, COST PER SITE, with ATTACHMENT B included in this Amendment.**

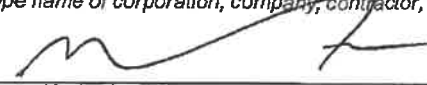

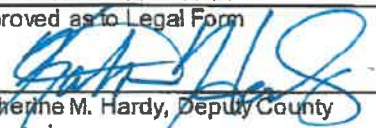

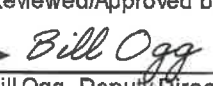
