AMENDMENT NO. 7

It is hereby agreed to amend Contract No. 16-938 effective June 18, 2025, as follows:

I. 2.1 Term

Paragraph 2.1 is amended to read as follows:

The Term of this Contract ("Term") shall begin January 1, 2025 and shall expire on December 31, 2026 but, may be terminated earlier in accordance with provisions of this contract.

II. 3.3 Maximum Amount

Paragraph 3.3 is amended to read as follows:

The Maximum Amount payable under the terms of this Contract shall be \$4,325,926.
