IT IS HEREBY AGREED AS FOLLOWS:

**AMENDMENT NO. 1
Assignment and Consent to Assignment**

WHEREAS, on March 28, 2023, San Bernardino County ("County") and Sierra Cybernetics, Inc. ("Assignor") entered into an agreement whereby Assignor agreed to provide professional information technology staffing services for a period from March 28, 2023, through March 27, 2028 ("Contract"); and

WHEREAS, subsequently Assignor and Sierra Cyber, LLC ("Assignee") entered into an agreement, wherein Assignor assigned all its rights, title, and interest, and delegated all of its obligations, responsibilities, and duties, in and to the Contract, to Assignee effective as of September 1, 2025; and

WHEREAS, the parties now desire to enter into an amendment to assign the contract from Assignor to Assignee;

NOW THEREFORE, effective as of the date this Amendment No. 1 is executed, the Contract is amended as follows:

1. The County hereby consents to the assignment of the Contract by the Assignor to the Assignee.
2. Assignee hereby accepts the assignment of all of Assignor's obligations, responsibilities, and duties under the Contract and all of Assignor's rights, title, and interest in and to the Contract.

- The County, in executing its consent to this Assignment and Consent, does not release Assignor from any claims or remedies it may have against Assignor under the Contract for obligations incurred prior to the effective date of the assignment.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
