IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 1 to Contract No. 24-17

San Bernardino County Flood Control District ("District") and MCC Equipment Rentals, Inc. ("Contractor"), hereby seek to enter into this Amendment No. 1 to amend Contract No. 24-17 as follows:

1. DELETE Section C. "TERM OF CONTRACT", and REPLACE it with a revised Section C., which shall now read as follows:

C. TERM OF CONTRACT

This Contract is effective January 9, 2024 and expires December 31, 2025 but may be terminated earlier in accordance with provisions of this Contract.

- 2. All other terms and conditions of Contract No. 24-17 shall remain unchanged.
- 3. This Amendment No. 1 shall take effect on the date it is last signed by both parties.
