### IT IS HEREBY AGREED AS FOLLOWS:

#### AMENDMENT NO. 1:

It is hereby agreed to amend Contract No. 22-246, effective March 28, 2023, as follows:

#### SECTION VIII. TERM

Section VIII. is amended to read as follows:

This Contract is effective as of April 1, 2022 and is extended from the original expiration date of March 31, 2023 to expire on June 30, 2023, but may be terminated earlier in accordance with provisions of Section IX of the Contract. The Contract term may be extended for two (2) additional one-year periods by mutual agreement of the parties.

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

All other terms and conditions of Contract No. 22-246 remain in full force and effect.

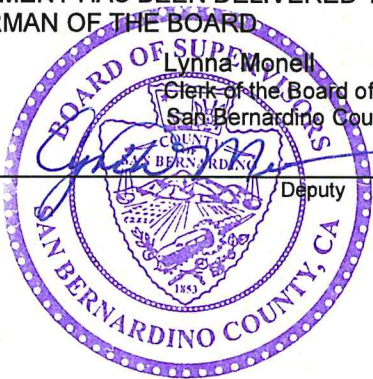
