### **AMENDMENT NO 1**

It is hereby agreed to amend Contract No. 24-616 effective July 1, 2025, as follows:

# C. FISCAL PROVISIONS Paragraph C.1 is amended to read as follows:

C.1 The maximum amount of payment under this Contract shall not exceed \$1,133,428 for the period of Fiscal Year 24/25 through Fiscal Year 25/26 with the option to extend the contract one (1) additional year at the indicated amounts below. The consideration to be paid to the County, as provided herein, shall be in full payment for all services and expenses incurred in the performance hereof, including travel and per diem.

### F. TERM OF CONTRACT

## Paragraph F.1 is amended to read as follows:

**F.1.** This Contract is effective as of July 1, 2024 and is extended from its original expiration date of June 30, 2025, to expire June 30, 2026, but may be terminated earlier in accordance with provision Section G of this Contract. The Contract term may be extended an additional one-year by mutual agreement of the parties.

### All other terms and conditions of Contract No. 24-616 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
