Customer is purchasing fifty (50) front-end terabytes ("TBs") of CommVault Complete Backup & Recovery – Per Front-End TB, Perpetual (CV-BR-FT) (the "New Licenses") from a CommVault authorized reseller ("Reseller") at Reseller's applicable pricing. Concurrent with the foregoing purchase, Customer is converting its existing sku-based perpetual licenses in CommCell ID F5800 to four hundred thirty-seven (437) TBs of CommVault Complete Backup & Recovery and twenty thousand (20,000) CommVault Complete Backup & Recovery Mailboxes per use (CV-BR-MB) and Ten (10) CommVault Complete Backup & Recovery for Endpoints, per user (CV-BR-EP) at no additional cost to Customer (collectively, the "Converted Licenses").
