**RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SAN BERNARDINO
RESCINDING RESOLUTION NO. 2020-201 AND
REQUESTING THAT THE CALIFORNIA DEPARTMENT OF TRANSPORTATION
ESTABLISH AN EMERGENCY PARKING ONLY ZONE ON STATE ROUTE 38, MENTONE AREA**

On Tuesday May 18, 2021, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Board of Supervisors desires that the California Department of Transportation to establish an "Emergency Parking Only" zone along portions of both the north and south sides of State Route 38, in the Mentone Area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- 1) Resolution No. 2020-201 is hereby rescinded; and,
- 2) Due to conditions affecting the welfare of the public utilizing State Route 38 (900038) near Mountain Home Village in the Mentone area, the Board of Supervisors deems it necessary and hereby resolves to:

Request that the California Department of Transportation establish an "Emergency Parking Only" zone per Vehicle Code 21718 along both the north and south side of State Route 38 from 0.35 miles west of Kilcare Road to Valley of the Falls Drive, in the Mentone area, excluding along the south side from 0.35 miles west of Kilcare Road easterly an approximate distance of 445 feet, from 0.69 miles east of Old Mill Creek Road easterly an approximate distance of 617 feet, and from 0.42 miles west of Valley of the Falls Drive easterly an approximate distance of 350 feet, and excluding along the north side from 0.13 miles west of Valley of the Falls Drive easterly an approximate distance of 245 feet, in the Mentone area.

The County Road Commissioner is directed to instruct Caltrans to remove current "No Stopping, Standing, or Parking" signs and to install "Emergency Parking Only" signs to be placed along said route.
