2	An ordinance of the Bloomington Recreation and Park
3	District to adopt by reference Sections 52.0130, 53.0603, 53.0604, 53.0605, 53.0606, and 53.0607 of the San Bernardino
4	County Code <u>and add new regulations</u> relating to <u>Ee</u> lectric Vehicle <u>Ccharging Sstation Ff</u> ees and <u>Ttime Llimits</u> , and to
5	amend to add Electric Vehicle Charging Station User Fees
6	for <mark>DD</mark> istrict Pparking Llots.
7	Be it ordained by the Board of Directors of the Bloomington Recreation and Park
8	District, County of San Bernardino-County, State of California, as follows:
9	SECTION 1. The following San Bernardino County Code Sections are hereby
10	adopted by reference for the regulation of District owned or maintained parking lots:
11	(A) Section 52.0130 Penalty
12	(B) Section 53.0603 Control Devices and Equipment, and Marking of Stalls
13	(C) Section 53.0604 Parking Regulations
14	(D) Section 53.0605 Speed Limit
15	(E) Section 53.0606 Classification of Offenses and Penalties
16 17	(F) Section 53.0607 Removal or Towing of Vehicles
17 18	SECTION 2. The following new regulations are hereby adopted to apply to District
	owned or maintained parking lots:
19 20	(A) Electric Vehicle Fees and Time Limits
20	(1) The Electric Vehicles (EV <u>s</u>) charging station monitors shall display
21	the schedule of fees and time limits, if any, established by the Board of Directors.
22	As a convenience to vehicle owners, the applicable fee, if any, may be displayed
23 24	on the EV charging station application.
24 25	(2) EV charging stations are intended for EVs and plug-in hybrid electric
25 26	vehicles (PHEVs) that need to be charged. EVs and PHEVs not utilizing the service
20 27	or parking for longer than is designated by signage are subject to citation as
27	provided in San Bernardino County Code Section 53.0606 and removal as
20	provided in San Bernardino County Code Section 53.0607.

1	(3) Electric vehicle charging station user fees shall be as provided in the
2	ordinance setting forth the District's adopted recreation and park fees.
3	SECTION 3. Whereas on April 25, 2023, the Board of Directors of the Bloomington
4	Recreation and Park District approved fees for the fiscal year 2023-24 that become
5	effective July 1, 2023. Effective June 8, 2023, the following fee is added to the approved
6	fees for the fiscal year 2023-24 as Section 10, to read:
7	10. Electric Vehicle Charging Station User Fees
8	Electric vehicle charging station user fees shall be \$0.32/kWh (plus all vendor
9	operator fees at actual cost) if vehicle is charging (4 hour maximum charge time),
10	plus \$0.20/minute overstay fee after a 10 minute grace period (\$12.00/hour,
11	maximum of \$48).
12	SECTION <u>34</u> . The Board of Directors declares that it would have adopted this
13	ordinance and each section, sentence, clause, phrase, or portion of it irrespective of the
14	fact that any one or more sections, subsections, clauses, phrases or portions of it be
15	declared invalid or unconstitutional. If for any reason any portion of this ordinance is
16	declared invalid or unconstitutional, then all other provisions of it shall remain valid and
17	enforceable.
18	SECTION <u>45</u> . This ordinance shall take effect thirty (30) days from the date of
19	adoption.
