

RESOLUTION NO. 2024-55

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE TV-5 (MESA TELEVISION), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone TV-5, therefore, hereby finds and determines:

(a) That on November 7, 1995, the electors of County Service Area 70, Zone TV-5, duly authorized a special tax levy for television services.

(b) That the amount of such tax shall not exceed \$25 per improved parcel, per year.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone TV-5, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$25 per improved parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.
