IT IS HEREBY AGREED AS FOLLOWS:

Pursuant to Section 10 of Agreement No. 22-390 between the SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT, hereinafter called "SBCFPD," and the CITY OF UPLAND, hereinafter called "CITY." CITY and SBCFPD agree to amend the MOU as follows:

1. Section 2 is deleted and replaced with the following:
2. CITY shall compensate SBCFPD at the rates set forth below:

NOTE: Equipment Standby Fees will be billed at 50% of the fee listed above.

A. The rates listed above will be from the period of July 1, 2024, through June 30, 2025.

All other terms of Agreement No. 22-390 shall remain in full force and effect.

This Amendment contains the entire agreement between the Parties to this Amendment relating to the settlement and transactions contemplated hereby, and supersedes any and all prior agreements, understandings, representations, and statements between the Parties, whether oral or written, and whether by a Party or such Party's legal counsel. The Parties are entering into this Amendment based solely on the representations and warranties herein and not based on any promises, representations, and/ or warranties not found herein. This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

This Amendment No. 1 shall take effect on July 1, 2024.
