IT IS HEREBY AGREED AS FOLLOWS:

This is Amendment No. 1 to Master Student Internship Agreement No. 21-631 (Agreement) between the San Bernardino County Fire Protection District (SBCFPD) and Victor Valley Community College District (VVCCD) associated with its Department of Emergency Medical Services Program.

SBCFPD and the VVCCD agree to amend the Agreement as follows:

1. The Term of Agreement in Section 5 is DELETED and REPLACED with the following:

5. TERM OF AGREEMENT

This AGREEMENT is effective from the Effective Date and expires on June 30, 2029, but may be terminated earlier in accordance with the provisions of this AGREEMENT. Either party may terminate this AGREEMENT without cause after giving the other party thirty (30) days advance written notice of its intention to so terminate.

2. The address for SBCFPD in Section 10 is deleted and replaced with the following:

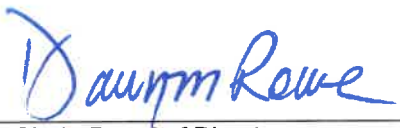

3. All other terms of Agreement No. 21-631 shall remain in full force and effect.

4. This Amendment No. 1 is effective as of the date executed by both parties.
5. This Amendment No. 1 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
