WHEREAS, San Bernardino County (COUNTY) and Mariposa Landscapes, Inc. (Contractor) entered into Contract No. 22-271 (Agreement) for mowing, maintenance, fertilization and rodent control services at five of its Regional Parks; and:

WHEREAS, the parties now desire to extend the term of the Agreement through May 31, 2026; and,

WHEREAS, the parties now desire to amend the Agreement to reflect the extension of the term.

NOW, THEREFORE, in consideration of mutual covenants and conditions, the parties hereto agree to amend Contract No. 22-271 as follows:

Section V. Term of Contract Amend the first paragraph of Section V to read as follows:

This Contract is effective as of June 1, 2022, and expires May 31, 2026, but may be terminated earlier in accordance with provisions of this Contract. The Contract term may be extended for one additional one-year period by mutual agreement of the parties.

Section VII. Fiscal Provisions Amend Section VII.A to read as follows:

A. The maximum payment under this Agreement for the initial term shall not exceed \$1,674,201.03. The maximum payment for the amended term from May 31, 2025, through May 31, 2026, shall not exceed \$590,868.01. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all of Contractor's services and expenses incurred in the performance hereof.

All other provisions and terms of Contract No. 22-271 shall remain the same.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
