

RESOLUTION NO. 2022-106

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, CONFIRMING THE REQUIRED LEVY OF ASSESSMENTS FOR SAN BERNARDINO COUNTY ASSESSMENT DISTRICT NO. 2018-1 (SNOWDROP ROAD), FOR THE FISCAL YEAR 2022-23

On Tuesday June 28, 2022, on motion of Supervisor Rutherford, duly seconded by Supervisor Cook and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Board of Supervisors (the "Board of Supervisors") of San Bernardino County (the "County") has conducted proceedings under the Municipal Improvement Act of 1913, Division 12 of the California Streets and Highways Code (the "Code"), for the formation of San Bernardino County Assessment District No. 2018-1 (Snowdrop Road) (the "Assessment District") and to authorize the levy of assessments, related diagram were recorded in the office of the Director of Department of Public Works, Special Districts of the County, acting as the Superintendent of Streets, and with the County Recorder of San Bernardino County;

WHEREAS, the Board of Supervisors, as the legislative body of the Assessment District, is authorized under the Act to levy certain special taxes with the Assessment District to pay for certain public services (the "Improvements" or "Maintenance") and to levy certain Assessments within the Assessment District to pay for the costs of certain public facilities;

WHEREAS, the Board of Supervisors, pursuant to Resolution No. 2018-20, adopted by the Board of Supervisors of the County on March 13, 2018, authorized and levied the Improvement Assessments and Maintenance Assessments within the Assessment District, as applicable;

WHEREAS, Section 10603 of the Act provides that the legislative body of the assessment district may provide, by resolution, for the levy of the improvement assessment, Section 10404 of the Act provides that the legislative body of the assessment district may provide, by resolution, for the levy of the maintenance assessment in the current year or future tax years at the same rate or at a lower rate than the rate provided by resolution, if the resolution is adopted and a certified list of all parcels subject to the assessment levied including the amount of the tax to be levied on each parcel for the applicable tax year, is filed by the clerk or other official designated by the legislative body with the county auditor on or before the 10th day of August of that tax year; and

WHEREAS, the Board of Supervisors desires to levy the Assessments within the Assessment District, as applicable, for Fiscal Year 2022-2023.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

Section 1. All of the above recitals are true and correct.

Section 2. The Board of Supervisors hereby levies the Assessment Taxes for the Fiscal Year 2022-23 at the rates and with respect to the parcels as set forth in Exhibit A and Exhibit B hereto. The Director of the Department of Public Works – Special Districts of the County is hereby authorized and directed to file with the San Bernardino County Auditor-Controller/Treasurer/Tax Collector no later than August 10, 2022, a certified list of parcels subject to the Assessment including the amount of the Assessment to be levied on each parcel for Fiscal Year 2022-23.

Section 3. The officers and agents of the County are, and each of them hereby is, authorized and directed to execute and deliver any and all documents and instruments and to do and cause to be done any and all acts and things necessary or proper for carrying out the levy of the Assessments for Fiscal Year 2022-23 as provided in this Resolution.

Section 4. All actions heretofore taken by the officers and agents of the County with respect to the levy of the Assessments for Fiscal Year 2022-23 are hereby approved, confirmed and ratified.

Section 5. This Resolution shall take effect immediately upon its adoption.
