The Contract Documents for the above referenced project are hereby amended in the following manner and the following manner only:

- I. All provisions of this Addendum No. 2 are hereby incorporated into the Contract Documents, and Bidders shall account for all provisions pursuant to this Addendum No. 2 in submitting their bid proposals. **Each Bidder shall include a dated and signed copy of this Addendum with their sealed bid proposal.**

1. ITEM NO. 1: LICENSING REQUIREMENT CLARIFICATION

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Advertisement for Bids of the Specifications

- A. Contractors are advised that the sixth paragraph in the Advertisement for Bids section of the bid package issued on September 12, 2024 shall be replaced with:

Each bidder shall be a licensed contractor pursuant to the Business and Professions Code and shall be licensed in the following classification of contractor's license, for the work bid upon, and must maintain the license throughout the duration of the contract: California Class A (General Engineering Contractor) Contractor's Licenses **or a C-53 (Swimming Pool Contractor) License**. In order to be deemed responsive, the bidder must list, in the bid forms, at least three (3) projects of similar size and scope that it has completed over the last five years.

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications:

- A. Contractors are advised that item 5. Registration of Contractors in the Instructions to Bidders section of the bid package issued on September 12, 2024 shall be replaced with:

All bidders shall be licensed in accordance with the provisions of Chapter 9, Division 3, of the Business and Professions Code of the State of California and possess a California Class A (General Engineering Contractor) License or a C-53 (Swimming Pool Contractor) License

at the time of the scheduled bid opening and which must be which must be maintained throughout the duration of the contract.

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Bid Proposal of the Specifications:

- A. Contractors are advised that the State Licenses paragraph in the Bid Proposal section, page BP-4 of the bid package issued on September 12, 2024 shall be replaced with:

The undersigned hereby certifies that it is currently the holder of a valid California Class A (General Engineering Contractor) Contractor's Licenses **or a C-53 (Swimming Pool Contractor) License** as a contractor in the State of California and that the license is the correct class of license for the bid requirements and work described in the project drawings and specifications. The undersigned also certifies that all subcontractor(s) listed under the Designation of Subcontractors section of the Bid Proposal are currently the holder of a valid contractor's license(s) in the State of California and the license is the correct class of license for the work to be performed by the subcontractor(s).

2. ITEM NO. 1: LAST DAY TO SUBMIT QUESTIONS

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications

- A. Contractors are advised that Item 1, Form and Preparation of Bid Proposal and Signature in the Instructions to Bidders section of the bid package issued on September 12, 2024 shall be replaced with:

Bidders shall be responsible for ensuring that they have received all addendums issued by the Department and the submittal of a bid shall be deemed to be based on the Bid Documents, as modified and/or clarified by any and all addenda..

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications

- B. Contractors are advised that Item 8, Interpretation of Drawings and Specifications in the Instructions to Bidders section of the bid package issued on September 12, 2024 shall be replaced with:

If any bidder is in doubt as to the true meaning of any requirements of drawings or specifications, or finds any discrepancies in, or omissions from the drawings or specifications, the bidder may submit to the engineer a written request for an interpretation or correction thereof. The written request must be received by **Friday, October 4, 2024 at 3:00 p.m.** The person making the request will be responsible for its prompt delivery.

Interpretations or corrections will be made only by addenda to specifications or by dated revisions or drawings with a copy of each addition or change being furnished through the District to each prospective bidder. Only a written interpretation or correction by Addendum shall be binding.
