MULTIPLE PRODUCT PURCHASE AGREEMENT

This Multiple Product Purchase Agreement (the "Agreement"), effective as of January 14, 2025(the "Effective Date"), is by and between Integra LifeSciences Sales LLC, a Delaware corporation with an address of 1100 Campus Road, Princeton, New Jersey 08540 ("Integra") and San Bernardino County, on behalf of Arrowhead Regional Medical Center ("County"), as set forth on Schedule 1.

WHEREAS, County desires to purchase certain products (as set forth in Schedule 2) (each hereinafter referred to as a "**Product**" and collectively as the "**Products**"); and

WHEREAS, Integra desires to provide such Products to County on the terms hereinafter provided.

NOW THEREFORE, Integra and County, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and intending to be legally bound, agree as follows:

- 1. <u>Contract Year</u>. This Agreement shall have three (3) Contract Years (as defined below). For purposes of this Agreement, the first Contract Year shall begin on the Effective Date and end twelve (12) months thereafter; the second and third Contract Years shall begin on the next day following the end of the previous Contract Year and end twelve (12) months thereafter (collectively, the "Contract Years" and each, individually, a "Contract Year").
- 2. <u>Pricing and Discounts.</u> County will pay Integra the prices for the Products as set forth in Schedule 2, subject to the price increases or decreases, as applicable, based on County's utilization of the Products. While Integra shall have the right to increase the list prices on any or all of its products at any time during the term of the Agreement, County shall only be subject to price increases for the Products in Schedule 2 as set forth herein.
- a. The discount for each Product will be taken at the time of the shipment of such Product and disclosed on the invoice Integra sends to County in accordance with Section 6.b. Integra shall have the right to monitor County's purchases on a quarterly basis to determine the applicable pricing for the Products as set forth in Schedule 3.
- b. County acknowledges that it is the intent of the parties that this Agreement will comply with the "anti-kickback" statute pertaining to the Medicare and Medicaid programs and the safe harbor for discounts contained in 42 CFR § 1001.952(h).
- 3. Payment Terms and Shipping. All payments under this Agreement are due net sixty (60) days from the date of the invoice and shall be made by check, ACH transaction or bank wire transfer to the address or bank remit instructions referenced on our invoice. Shipping terms are FOB Origin, and risk of loss shall pass from Integra at such FOB locations. Shipping costs are prepaid by Integra and will be invoiced to the County. County agrees to pay such shipping costs net sixty (60) days from the date of the invoice. Upon County's receipt of any Products shipped hereunder, County shall inspect the goods and notify Integra in writing within five (5) days after the goods have been received by County of any claims for shortages, defects or damages and shall hold the goods for Integra's written instructions concerning disposition.
- 4. Ordering. County agrees to order all Products through Integra Customer Service at (800) 997-4868, or as otherwise directed by Integra from time to time. In the event County is directed to issue a purchase order for Products, the terms of such purchase order shall not be binding on the parties except

for the following: name of Product, quantity ordered and delivery address. No modification of, addition to, or waiver of, any of the provisions of this Agreement shall be effected by the acknowledgement or acceptance of any purchase order or other form containing additional or different terms or conditions to those contained herein, whether or not signed by an authorized representative of either party.

- 5. <u>Use of Products</u>. County agrees to use the Products in accordance with the requirements of the Product packaging instructions and labeling.
- 6. <u>Representations, Warranties and Covenants Regarding Discounts</u>. In addition to the statement of the intent of the parties set forth in Section 2, the parties hereto represent, warrant and covenant as follows:
- a. Representations, Warranties and Covenants of County. County represents and warrants that it is an entity that reports its costs on a cost report required by the Department of Health and Human Services or a State agency, as described in 42 CFR § 1001.952(h)(1)(i). County acknowledges that Integra has informed it of its obligations to report discounts earned on Product purchased from Integra pursuant to this Agreement, and represents and warrants, covenants and agrees that it and each County will comply with all of the standards set forth in the requirements for establishment of safe harbor for discounts set forth more fully at 42 CFR §§ 1001.952 (h)(1)(i)(A) through (D).
- b. <u>Representations, Warranties and Covenants of Integra</u>. Integra represents, warrants, covenants and agrees that it will fully and accurately report discounts earned by the County on goods purchased from Integra pursuant to this Agreement (the Products) on invoices or statements submitted to the County in connection with such purchases, and will comply otherwise with all of the standards set forth in the requirements for establishment of safe harbor for discounts set forth more fully at 42 CFR §1001.952(h)(2)(ii).

7. Term and Termination.

a. <u>Term.</u> The term of this Agreement shall commence on the Effective Date and, unless otherwise terminated as provided herein, shall continue in full force and effect until January 13, 2028 ("Initial Term"). This Agreement may be extended for two (2) additional one-year periods upon the mutual written agreement of the parties, which may include a renegotiation of the prices of the Products ("Renewal Term"). Nothing in this Agreement shall be construed to obligate either party to extend the Term of this Agreement.

b. Termination.

i. Termination Rights.

- 1. Breach. In the event that this Agreement is materially breached by either party, the nonbreaching party may give the breaching party written notice requiring it to remedy such breach. If such breach is not fully remedied within sixty (60) days after receipt of such notice or the parties have not agreed on a plan to remedy such breach, the nonbreaching party shall, in addition to other remedies available to it, be entitled to terminate this Agreement upon written notice thereof to the breaching party. If County breaches its obligations to make the minimum purchase requirements pursuant to Section 2.a. of this Agreement, it shall be deemed to have "materially breached" this Agreement.
- 2. <u>Bankruptcy or Insolvency</u>. This Agreement may be terminated by either party upon notice to the other should the other party (i) become insolvent, or (ii)

file a petition under any bankruptcy or insolvency law or have any such petition filed against it which is not stayed within ninety (90) days of such filing.

- 3. <u>Termination for Convenience</u>. Either party may terminate this Agreement without cause and without penalty upon thirty (30) days' advanced written notice to the other party. This Agreement does not create an obligation on Integra to supply Product(s). For the avoidance of doubt, the provision of Products by Integra pursuant to this Agreement is subject to Product availability and/or decisions regarding Product allocation made by Integra in its sole discretion.
- ii. <u>Certain Rights</u>. Any termination of this Agreement shall be without prejudice to any rights or right of action vested in either party on the date of termination.

8. Limited Product Warranty.

- a. Integra warrants that it will convey good title to each Product sold to County under this Agreement, free from any security interest, lien or other encumbrance.
- b. Integra warrants that the Products supplied to County under this Agreement will, at the time of delivery, conform to Integra's standard limited warranty that is provided on a Product by Product basis.
- c. INTEGRA MAKES NO WARRANTIES OTHER THAN THOSE STATED IN THIS AGREEMENT. INTEGRA DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND ANY IMPLIED WARRANTY ARISING FROM COURSE OF PERFORMANCE, COURSE OF DEALING, USAGE OF TRADE OR OTHERWISE.
- 9. <u>Limitation of Liability</u>. EXCEPT FOR THIRD PARTY CLAIMS OR CLAIMS FOR GROSS NEGLIGENCE, WILLFUL MISCONDUCT, VIOLATIONS OF LAW, OR BREACHES OF CONFIDENTIALITY, THE LIABILITY OF INTEGRA AND ITS AFFILIATES IN THE AGGREGATE UNDER AND WITH RESPECT TO THIS AGREEMENT AND THE PERFORMANCE OR NONPERFORMANCE OF THIS AGREEMENT AND ANY PRODUCTS (INCLUDING, WITHOUT LIMITATION, THE PRODUCTS) FURNISHED UNDER THIS AGREEMENT SHALL BE LIMITED TO TWO TIMES (2X) THE VALUE OF THE PRODUCTS PURCHASED BY COUNTY IN THE CALENDAR YEAR IN WHICH THE LIABILITY ARISES. INTEGRA SHALL NOT BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES, LOSS OF PROFIT, OR LOSS OF USE. FOR THE AVOIDANCE OF DOUBT, THE FOREGOING LIMITATION OF LIABILITY SHALL NOT APPLY WITH RESPECT TO ANY CLAIMS FOR INDEMNIFICATION PURSUANT TO SECTION 10 OF THIS AGREEMENT.
- 10. <u>Indemnification</u>. Integra shall indemnify and hold harmless County, and its affiliated entities, against all third party claims or actions arising out of (a) breach of any representation, warranty, or other obligation under this Agreement, (b) infringement or violation of any patent, copyright, trade secret, trademark, or other third party intellectual property right, or (c) any personal injury or damage to property resulting from Integra's negligent acts or omissions. The foregoing indemnification obligations shall not apply to the extent that the underlying claim giving rise to the indemnification request was caused by the negligence or intentional misconduct of County. County shall indemnify, defend, and hold harmless Integra from any liability in tort, contract, or any other theory of law arising out of, directly or indirectly, County's negligence, County's failure to use the Products in accordance with the package

labeling or the requirements of the warranty, or by reason of County's failure to perform its obligations contained herein, including without limitation, the failure to comply with applicable law.

11. Miscellaneous.

- Confidentiality. County agrees not to disclose the terms of this Agreement, including without limitation, the pricing arrangements, or any other Confidential Information (as defined below), to any third party, except that County may disclose the terms of this Agreement, pricing arrangements and any other Confidential Information (i) as required by law and (ii) to federal and state health care payors (including without limitation, Medicare and Medicaid payors) and to other health care regulators. "Confidential Information" is any information, whether in writing or disclosed orally to County, including without limitation, the terms of this Agreement, all information relating to existing and potential customers, suppliers, markets, contracts, prices, products, procedures, technologies, know-how, processes, inventions, developments, methods of manufacture or any other information relating to Integra and its affiliates, except to the extent that any such information as of the date of disclosure to County was (i) known to County and such knowledge can be substantiated by reasonable documentation; (ii) disclosed in published literature; (iii) generally available to the industry; or (iv) obtained by County from a third party, provided that such third party had no obligation of confidentiality to Integra or any of its affiliates relating to the information. Integra acknowledges that this Agreement is subject to local and state open meetings and public records laws, including without limitation, the San Bernardino County Sunshine Ordinance, County Code of Ordinances Section 19.0101, California Government Code 54950, and California Public Records Act (Government Code Section 7920.005) (collectively, "Regulations"), and County's obligations hereunder cannot conflict with its compliance with the Regulations.
- b. <u>Indirect Purchases</u>. Purchases made through a third-party wholesale distributor (a "Distributor") are subject to the terms and conditions negotiated between the Distributor and the County (e.g., payment terms, service fees, shipping fees and product surcharges). A Distributor will be responsible for delivering all Products purchased by the Participant through that Distributor.
- c. <u>Additional Products</u>. Integra may at its discretion add products (e.g. Product extensions, New Products) to Schedule 2 after providing notice to the County.
- d. <u>Notices</u>. All notices, demands or other communications required or permitted to be given pursuant to this Agreement shall be effective only if given in writing, hand-delivered, e-mail or sent by courier service or certified or registered mail, return receipt requested, postage prepaid and addressed as follows:

e. <u>Governing Law.</u> This Agreement shall be construed, interpreted and enforced in accordance with, and governed by, the laws of the State of Delaware, without giving effect to choice of law principles.

- f. <u>Assignment and Binding Effect</u>. This Agreement is personal and neither party may assign, transfer, or otherwise dispose of all or any portion of its rights under this Agreement without the prior written consent of the other party, and any such purported assignment will be void. Notwithstanding the foregoing, this Agreement may be assigned by either party to an entity controlling, controlled by, or under common control with such party, without the other party's consent.
- g. Remedies. No remedy herein conferred is intended to be exclusive of any other remedy, and each and every such remedy shall be cumulative and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise. Integra and County each acknowledge that damages alone may not be an adequate remedy for any breach or violation of its obligations hereunder and that in addition to any other remedies to which the other party may be entitled hereunder or otherwise, such other party shall be entitled to injunctive relief, including specific performance, with respect to such obligations in any court of competent jurisdiction.
- h. <u>Waivers</u>. No waiver by any party hereto or any failure by any other party hereto to keep or perform any covenant or condition of this Agreement shall be deemed to be a waiver of any preceding or succeeding breach of the same or other covenant or condition. No failure to enforce any provision hereof shall operate as a waiver thereof or be deemed to be a release of any rights granted hereunder.
- i. <u>Severability</u>. If any provision of this Agreement would be held or made invalid or unenforceable by a court decision, statute, rule or otherwise, such provision shall be construed in such a way as to make it valid and enforceable to the maximum extent possible. The invalidity or unenforceability of any provision of this Agreement shall not affect the remaining provisions of this Agreement, which shall be enforceable to the maximum extent permitted by law.
- j. <u>Entire Agreement</u>. The parties acknowledge that this Agreement and any attachments, schedules, exhibits and riders hereto constitute the complete and exclusive understandings between the parties with respect to the subject matter of this Agreement. Except as otherwise stated in this Agreement, no amendment of this Agreement may be made or rider added except in a writing duly signed by each of the parties hereto.
- k. <u>Headings</u>. The headings in this Agreement are for convenience of reference only and in no way define or limit any of the provisions hereof or otherwise affect their construction or effect.
- l. <u>Counterparts</u>. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
- m. <u>Survival</u>. The provisions of Sections 3, 5, 6, 7(b)(ii), 8, 9 and 10 shall survive the termination of this Agreement for any reason.
- n. <u>Consolidated Service Center</u>. If County uses a central distribution hub or consolidated service center for distribution of Products to affiliated facilities, it shall provide sales tracing information of such Product distributions to Integra at no cost. The sales tracing report shall be submitted monthly to <u>csschargebacks@integralife.com</u> in excel format and include the following information:

o. <u>Campaign Contribution Disclosure (SB1439)</u>. Integra has disclosed to the Customer using Attachment B - Campaign Contribution Disclosure Senate Bill 1439, whether it has made any campaign contributions of more than \$250 to any member of the San Bernardino County ("County") Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Agreement was approved by the Board of Supervisors. Integra acknowledges that under Government Code section 84308, Integra is prohibited from making campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Agreement. In the event of a proposed amendment to this Agreement, the Integra will provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment. Campaign contributions include those made by any agent/person/entity on behalf of the Integra or by a parent, subsidiary or otherwise related business entity of Integra.

ATTACHMENT A

INSURANCE REQUIREMENTS

Integra shall, at its own cost and expense, maintain in force during the term of this Agreement, insurance coverage in the types and limits set forth below:

- a. Workers' Compensation/Employer's Liability A program of Workers' Compensation insurance or a state-approved, self-insurance program in an amount and form to meet all applicable requirements of the Labor Code of the State of California, including Employer's Liability with \$250,000 limits covering all persons including volunteers providing services on behalf of Integra and all risks to such persons under this Agreement. If Integra has no employees, it may certify or warrant to the County that it does not currently have any employees or individuals who are defined as "employees" under the Labor Code and the requirement for Workers' Compensation coverage will be waived by the County's Director of Risk Management. With respect to contractors that are non-profit corporations organized under California or Federal law, volunteers for such entities are required to be covered by Workers' Compensation insurance.
- b. <u>Commercial/General Liability Insurance</u> Integra shall carry General Liability Insurance covering all operations performed by or on behalf of Integra providing coverage for bodily injury and property damage with a combined single limit of not less than one million dollars (\$1,000,000), per occurrence. The policy coverage shall include:
 - i. Premises operations and mobile equipment.
 - ii. Products and completed operations.
 - iii. Broad form property damage (including completed operations).
 - iv. Explosion, collapse and underground hazards.
 - v. Personal injury.
 - vi. Contractual liability.
 - vii. \$2,000,000 general aggregate limit.
- c. <u>Automobile Liability Insurance</u> Primary insurance coverage shall be written on ISO Business Auto coverage form for all owned, hired and non-owned automobiles or symbol 1 (any auto). The policy shall have a combined single limit of not less than one million dollars (\$1,000,000) for bodily injury and property damage, per occurrence. If Integra is transporting one or more non-employee passengers in performance of Agreement services, the automobile liability policy shall have a combined single limit of two million dollars (\$2,000,000) for bodily injury and property damage per occurrence. If Integra owns no autos, a non-owned auto endorsement to the General Liability policy described above is acceptable.
- d. <u>Umbrella Liability Insurance</u> An umbrella (over primary) or excess policy may be used to comply with limits or other primary coverage requirements. When used, the umbrella policy shall apply to bodily injury/property damage, personal injury/advertising injury and shall include a "dropdown" provision providing primary coverage for any liability not covered by the primary policy. The coverage shall also apply to automobile liability.
- e. <u>Cyber Liability Insurance</u> Cyber Liability Insurance sufficiently broad to respond to the duties and obligations in this Agreement with limits of no less than \$1,000,000 for each occurrence or event with an annual aggregate of \$2,000,000.

- 1. Additional Insured. All policies, except for Worker's Compensation, Errors and Omissions and Professional Liability policies shall contain additional endorsements naming the County and its officers, employees, agents and volunteers as additional named insured with respect to liabilities arising out of the performance of services hereunder. The additional insured endorsements shall not limit the scope of coverage for the County to vicarious liability but shall allow coverage for the County to the full extent provided by the policy. Such additional insured coverage shall be at least as broad as Additional Insured (Form B) endorsement form ISO, CG 2010.11 85.
- 2. Waiver of Subrogation Rights. Integra shall require the carriers of required coverages to waive all rights of subrogation against the County, its officers, employees, agents, volunteers, contractors and subcontractors. All general or auto liability insurance coverage provided shall not prohibit Integra and Integra's employees or agents from waiving the right of subrogation prior to a loss or claim. All waivers of subrogation rights are provided only to the extent of liabilities assumed by Integra under this Agreement.
- 3. **Policies Primary and Non-Contributory**. For any claims relating to this Agreement, the policies required herein are to be primary and non-contributory with any insurance or self-insurance programs carried or administered by the County.
- 4. **Severability of Interests**. Integra agrees to ensure that coverage provided to meet these requirements is applicable separately to each insured and there will be no cross liability exclusions that preclude coverage for suits between Integra and the County or between the County and any other insured or additional insured under the policy.
- 5. **Proof of Coverage**. Integra shall furnish Certificates of Insurance to the County Department administering the Agreement evidencing the insurance coverage at the time the Agreement is executed, additional endorsements, as required shall be provided prior to the commencement of performance of services hereunder, which certificates shall provide that such insurance shall not be terminated or expire without thirty (30) days written notice to the Department, and Integra shall maintain such insurance from the time Integra commences performance of services hereunder until the completion of such services. Within fifteen (15) days of the commencement of this Agreement, Integra shall furnish a copy of the Declaration page for all applicable policies and will provide complete certified copies of the policies and endorsements immediately upon request.
- 6. Acceptability of Insurance Carrier. Unless otherwise approved by Risk Management, insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best" Insurance Guide rating of "A-VII".
- 7. **Deductibles and Self-Insured Retention**. Any and all deductibles or self-insured retentions in excess of \$10,000 shall be declared to and approved by Risk Management.
- 8. Failure to Procure Coverage. In the event that any policy of insurance required under this Agreement does not comply with the requirements, is not procured, or is canceled and not replaced, the County has the right but not the obligation or duty to cancel the Agreement.
- 9. Insurance Review. Insurance requirements are subject to periodic review by the County. The Director of Risk Management or designee is authorized, but not required, to reduce, waive or suspend any insurance requirements whenever Risk Management determines that any of the required insurance is not available, is unreasonably priced, or is not needed to protect the interests of the County. In addition, if the Department of Risk Management determines that heretofore unreasonably priced or unavailable types of insurance coverage or coverage limits become reasonably priced or available, the Director of Risk

Management or designee is authorized, but not required, to change the above insurance requirements to require additional types of insurance coverage or higher coverage limits, provided that any such change is reasonable in light of past claims against the County, inflation, or any other item reasonably related to the County's risk. Any change requiring additional types of insurance coverage or higher coverage limits must be mutually agreed to by the parties and made by written amendment to this Agreement.



ATTACHMENT B

CAMPAIGN CONTRIBUTION DISCLOSURE (SB 1439)

DEFINITIONS

Actively supporting the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
