#### **AMENDMENT No. 4**

#### IT IS HEREBY AGREED AS FOLLOWS:

Contract No. 15-886 to provide Electronic Health Records services by NaphCare, Inc. (CONTRACTOR) to the San Bernardino County Sheriff/Coroner/Public Administrator (Sheriff) and Probation Department (Probation) (collectively "COUNTY") is hereby amended, effective November 18, 2025, as follows:

- **SECTION 2. Period of Performance,** Paragraph 2.1 is hereby amended to read as follows:
  - 2.1 This Agreement shall be effective upon the Effective Date and continue in effect through December 15, 2027, with the option of the COUNTY to renew for one (1) additional three-year term. CONTRACTOR shall commence performance upon the Effective Date and shall diligently and continuously perform thereafter. All renewals shall be by written amendment and only upon approval of the San Bernardino County Board of Supervisors.
- **2. SECTION 3. Compensation.** Paragraph 3.1 is hereby amended to read as follows:
  - 3.1 The COUNTY shall pay the CONTRACTOR for services performed, products provided, and expenses incurred in accordance with the terms of Exhibit D, Payment Provisions. Maximum payments by COUNTY to CONTRACTOR shall not exceed \$726,040 annually, including all expenses. The COUNTY is not responsible for any fees or costs incurred above or beyond the contracted amount and shall have no obligation to purchase any specified amount of services or products. Unless otherwise specifically stated in Exhibit D, COUNTY shall not be responsible for payment of any of CONTRACTOR's expenses related to this Contract.

- **3. SECTION 23. General,** Paragraph 23.15 is hereby deleted, in its entirety, and is replaced with a new Paragraph 23.15, as follows:
  - 23.15 Levine Act Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439) CONTRACTOR has disclosed to the COUNTY using Attachment III Levine Act Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), whether it has made any campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector, and the District Attorney] within the earlier of: (1) the date of the submission of CONTRACTOR's proposal to the County, or (2) 12 months before the date the Contract was approved by the Board of Supervisors. CONTRACTOR acknowledges that under Government Code section 84308, Contractor is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other COUNTY elected officer for 12 months after the County's consideration of the Contract.

In the event of a proposed amendment to the Contract, the CONTRACTOR will provide the COUNTY a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the Board of Supervisors or other COUNTY elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the CONTRACTOR or by a parent, subsidiary, or otherwise related business entity of CONTRACTOR.

- **4. SECTION 23. General,** Paragraph 23.16 is hereby added to the Contract, as follows:
  - 23.16 Prohibition on Contracting with Entities that Require Certain Internal Confidentiality Agreements or Statements-Representation (FAR 52.203-18)

In compliance with Federal Acquisition Regulation 52.203-18, CONTRACTOR shall not require employees or subcontractors of CONTRACTOR seeking to report waste, fraud, or abuse, to sign internal confidentiality agreements or statement prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information. To the extent CONTRACTOR has required employees or subcontractors to sign internal confidentiality agreements or statements in the past, CONTRACTOR shall notify current employees and subcontractors that those prohibitions and restrictions are no longer in effect. CONTRACTOR shall include this clause in all subcontracts.

- **5. SECTION 23. General,** Paragraph 23.17 is hereby added to the Contract, as follows:
  - 23.17 Use of Biobased Products (FAR 52.223-1)

CONTRACTOR certifies that to the extent biobased products are purchased using Contract funds, NaphCare shall comply with Federal Acquisition Regulation 52.223-1.

- **6. Section 23. General,** Paragraph 23.18 is hereby added to the Contract, as follows:
  - 23.18 Service Contract Labor Standards (FAR 52.222-52, 52.222-53, 22.1003-4)

To the extent applicable, CONTRACTOR agrees to comply with and to provide any information necessary for the County to comply with Federal Acquisition Regulations 52.222-52, 52.222-53, and 22.1003-4.

# Attachment III Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439)

The following is a list of items that are not covered by the Levine Act. A Campaign Contribution Disclosure Form will not be required for the following:

- Contracts that are competitively bid and awarded as required by law or County policy
- Contracts with labor unions regarding employee salaries and benefits
- Personal employment contracts
- Contracts under \$50,000
- Contracts where no party receives financial compensation
- Contracts between two or more public agencies
- The review or renewal of development agreements unless there is a material modification or amendment to the agreement
- The review or renewal of competitively bid contracts unless there is a material modification or amendment to the agreement that is worth more than 10% of the value of the contract or \$50,000, whichever is less
- Any modification or amendment to a matter listed above, except for competitively bid contracts.

#### **DEFINITIONS**

Actively supporting or opposing the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

<u>Agent:</u> A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
