ORDINANCE NO.

An ordinance of San Bernardino County, State of California, to amend section 12.2303 of the San Bernardino County Code, relating to duties of the Clerk of the Board of Supervisors.

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Section 12.2303 of the San Bernardino County Code is amended, to read:

Section 12.2303 Duties of Clerk of the Board of Supervisors.

The Clerk of the Board of Supervisors (Clerk) shall perform all duties related to the following activities and functions:

- (a) Applications for licenses/permits;
- ~~(b) Sale of school and other bonds;~~
- ~~(c) Public Safety Authority;~~
- ~~(d) Building Authority;~~
- ~~(e) Chino Building Authority;~~
- ~~(f) Redlands Museum Building Authority;~~
- ~~(g) Yucca Valley Community Center Authority;~~
- ~~(h) Authority for the Handicapped;~~
- ~~(i) Inland Counties Emergency Medical Authority;~~
- (j) Assessment Appeals Boards and Hearing Officers;
- ~~(k) Flood Control District~~All separate Board of Supervisors (including when sitting as the Board of Directors) governed entities;
- (l) Roster of Public Agencies;
- (m) Conflict of Interest Codes;
- (n) Administering of Oaths;

1 (eg) Certification of County Ordinances and Resolutions and Certification of
2 Ordinances and Resolutions of all Board of Supervisors (including when sitting as the
3 Board of Directors) governed entities~~Special Districts governed by Board of Supervisors;~~

4 (ph) Accept claims and service on behalf of the County or other entities governed
5 by the Board of Supervisors (including when sitting as the Board of Directors)~~claims and~~
6 ~~service on behalf of County;~~

7 (qi) Other duties and responsibilities of the Clerk required by law;

8 (fj) Filing of all papers required or permitted to be filed with the County Clerk by
9 the California Environmental Quality Act, Public Resources Code §§ sections 21000 and
10 following.

12 SECTION 2. The Board of Supervisors declares that it would have adopted this
13 ordinance and each section, sentence, clause, phrase, or portion of it irrespective of the
14 fact that any one or more sections, subsections, clauses, phrases or portions of it be
15 declared invalid or unconstitutional. If for any reason any portion of this ordinance is
16 declared invalid or unconstitutional, then all other provisions of it shall remain valid and
17 enforceable.

19 SECTION 3. This ordinance shall take effect thirty (30) days from the date of
20 adoption.
