

RESOLUTION NO. 2025-171

**REVISED SENATE BILL 1 ROAD MAINTENANCE AND REHABILITATION ACCOUNT
PROJECT LIST FOR 2024-25**

On Tuesday, August 5, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure that the residents of San Bernardino County are aware of the projects proposed for funding in the County and which projects have been completed each fiscal year; and

WHEREAS, the County must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the Board of Supervisors adopted Resolution No. 2024-115 on July 9, 2024, approving the County's RMRA project list for fiscal year 2024-25; and

WHEREAS, since that time, the County has identified six new additional RMRA-eligible projects and desires to revise the fiscal year 2024-25 project list to include these projects; and

WHEREAS, the County anticipates receiving an estimated \$43,855,018 in RMRA funding in Fiscal Year 2024-25 from SB 1; and

WHEREAS, this is the seventh year in which the County has received SB 1 funding and will enable the County to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the County used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on high priority and cost-effective projects that also meet community priorities for transportation investment; and

WHEREAS, the 2023 California Statewide Local Streets and Roads Needs Assessment found that the County's streets and roads are in "good" condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into a "excellent" condition; and

WHEREAS, the revised RMRA project list supports the County's commitment to safety, mobility, fiscal responsibility, economic development through strategic infrastructure investment and will have significant positive benefits throughout the County.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of San Bernardino County, State of California, as follow:

1. The foregoing recitals are true and correct and are incorporated herein by reference.

2. The following six (6) additional projects are approved for inclusion in the revised fiscal year 2024-25 RMRA project list and shall be funded, in whole or in part, with fiscal year 2024-25 RMRA revenues:
