Water Conservation Outdoor Rebate Program

PROGRAM REQUIREMENTS (Rebate Credit Applied to Account)

- Rebate applies only to customers of the County of San Bernardino, Special Districts Department, Water and Sanitation Division, for qualifying purchases dated 07/01/2020 thru 06/30/2021.
- You must be a residential customer and simple fee owner of the single-family home, townhome, condominium, or manufactured home in which the sprinkler heads and/or weather-based irrigation controller was replaced.
- Applicant address must be located within one of the following established County Service Areas (CSA): CSA 42 - Oro Grande; CSA 64 – Spring Valley Lake; CSA 70 CG – Cedar Glen; CSA 70 F – Little Morongo; CSA 70 J – Oak Hills; CSA 70 W-3 – Hacienda Heights; and CSA 70 W-4 – Pioneertown.
- Sales Receipt: The original receipt must be submitted and the purchase date must be included on the receipt.
- Application must be submitted within 90 days of the product(s) purchase date.
- **Original UPC** for each product must be included with completed application.

- Rebates will be issued to those applicants who meet all rebate program requirements until funds are exhausted for each fiscal year.
- Rebate credit for each product will only be issued one time per service address.
- Rebate credit will be issued only to direct customers of the San Bernardino County Special Districts Department, Water and Sanitation Division, for qualifying product installed at an address located within the boundaries of the following established County Service Areas: (CSA): CSA 42 - Oro Grande; CSA 64 – Spring Valley Lake; CSA 70 CG – Cedar Glen; CSA 70 F – Little Morongo; CSA 70 J – Oak Hills; CSA 70 W-3 – Hacienda Heights; and CSA 70 W-4 – Pioneertown.
- The Water and Sanitation Division may request an inspection to verify installation of qualifying devices. If the device installation cannot be verified, the payee must reimburse the rebate program for rebate funds received.
- All issued rebate credits will be applied directly to the customer's water utility account.
- Rebates valid only on new/undamaged eligible items.
- Installation of the qualifying products is the sole responsibility of the applicant.
- The total amount of the issued rebate will not exceed the purchase cost for the products; this excludes all shipping and tax related expenses, which cannot be included in the total cost of the product.
- Rebate applications must be completed in full, including all necessary documentation including proof of purchase.
- Participating products purchased from a third-party website (eBay, Amazon, etc.) may be eligible for rebate, provided that the applicant provides proof that the product is both new and in its original packaging at the time of purchase.
- Special Districts Department does not endorse specific brands, products, or dealers; nor does it guarantee materials.
- Special Districts Department is not responsible for any taxes that may be associated with receiving a rebate.
- Special Districts Department cannot guarantee, due to uncontrollable circumstances, that installation of rebated products will result in lower water utility costs.
- All applicants release the liability of the Special Districts Department and their associated agents from any and all causes of actions that may arise from the installation or use of qualified products.
- By submitting an application to this rebate program, applicants are consenting to adhere to all terms and conditions of the program.
