Except as amended, all other terms and conditions of this Agreement remain as stated therein.

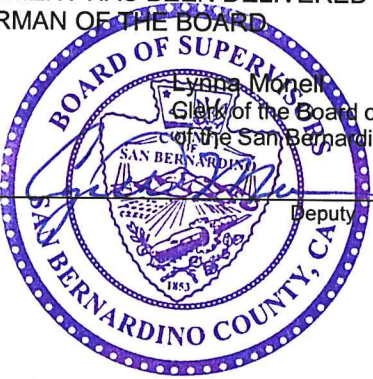
