AMENDMENT NO. 2

IT IS HEREBY AGREED AS FOLLOWS:

WHEREAS, the County of San Bernardino (County) and EccoVia, Inc. (Contractor) entered into an Agreement effective November 1, 2019 through October 31, 2020; and

WHEREAS, the County wishes to extend the term of the Contract through October 31, 2022; and

WHEREAS, the Parties now desire to amend the Contract;

NOW, THEREFORE, the County and Contractor mutually agree to amend the Agreement as follows:

1. Amend Term of Agreement to read as follows:

This Agreement is effective on November 1, 2019, and terminates on October 31, 2022, but may be terminated earlier in accordance with the provisions of this Agreement.

2. The Agreement amount is increased by \$446,712 for a total Agreement amount of \$646,314.32.

3. Add revised Attachment I - Pricing Summary and Scope of Work dated October 8, 2020 to the Agreement, increasing the number of licenses to an estimated 200 licenses for a 12-month period.

4. This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

All other terms and conditions of Agreement shall remain in full force and effect.

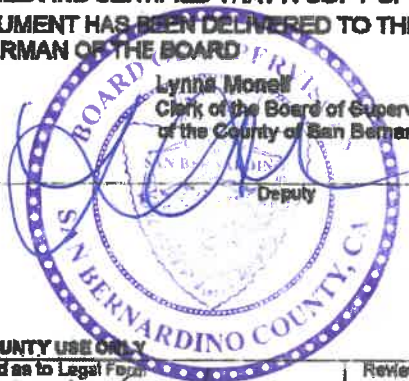
