**RESOLUTION OF THE BOARD OF DIRECTORS OF THE SAN BERNARDINO COUNTY
FIRE PROTECTION DISTRICT ACKNOWLEDGING THE RECEIPT OF THE 2024-25
COMPLIANCE REPORT PURSUANT TO CALIFORNIA HEALTH AND SAFETY CODE
SECTIONS 13146.2, 13146.3, AND 13146.4**

On Tuesday, November 18, 2025 on motion of Director Hagman, duly seconded by Director Baca, Jr., and carried, the following resolution is adopted by the Board of Directors of San Bernardino County Fire Protection District, State of California.

WHEREAS, State of California Senate Bill No. 1205 added Section 13146.4 to the California Health and Safety Code; and,

WHEREAS, Health and Safety Code sections 13146.2 and 13146.3 require all fire departments or fire districts, including the San Bernardino County Fire Protection District, that provide fire protection services to perform annual inspections in every building used as a public or private school, hotel, motel, lodging house, apartment house, and certain occupancies for compliance with building standards, as provided; and,

WHEREAS, Health and Safety Code section 13146.4 requires all fire departments, or fire districts, including the San Bernardino County Fire Protection District, that provide fire protection services to report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3 at the time of its annual budget review or at another time as determined by the administering authority; and,

WHEREAS, on June 11, 2019 (Item No. 114), the Board of Directors directed the Fire Chief/Fire Warden to annually prepare the compliance report and present it for receipt by the Board within 90 days from the end of each fiscal year, which 90-day time period was modified by the Board on October 27, 2020 (Item No. 90) to 120 days from the end of each fiscal year; and,

WHEREAS, the San Bernardino County Fire Protection District has prepared the 2024-25 compliance report, attached to this Resolution as Exhibit "A," and incorporated here by this reference; and,

WHEREAS, the Board of Directors of the San Bernardino County Fire Protection District intends this Resolution to fulfill the requirements of the Health and Safety Code regarding acknowledgment of receipt of the 2024-25 compliance report (Exhibit "A").

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the San Bernardino County Fire Protection District that said Board acknowledges receipt of the 2024-25 compliance report (Exhibit "A") prepared by the San Bernardino County Fire Protection District pursuant to Health and Safety Code sections 13146.2, 13146.3, and 13146.4.
