IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1:

It is hereby agreed to amend Contract No. 18-271, effective July 1, 2022, as follows:

SECTION V. FISCAL PROVISIONS

Amend Paragraph A to read as follows:

- A. The maximum amount of payment under this Contract shall not exceed \$2,500,000, of which \$1,650,000 may be federally funded, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem

SECTION VIII. TERM

Amend Section to read as follows:

The Contract is effective as of July 1, 2018, and is extended from its expiration date of June 30, 2022, to expire on June 30, 2023, but may be terminated earlier in accordance with the provisions of Section IX of the Contract.

All other terms and conditions for Contract No. 18-271 remain in full force and effect.

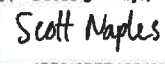

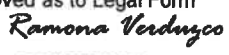

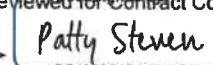
