**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY  
RATIFYING SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT ORDINANCE NO. FPD  
26-02, WHICH REPEALS ORDINANCE NO. FPD 23-01 AND ADOPTS THE SAN BERNARDINO  
COUNTY FIRE PROTECTION DISTRICT FIRE CODE, INCLUDING THE 2025 EDITION OF THE  
CALIFORNIA FIRE CODE WITH CERTAIN LOCAL CHANGES, MODIFICATIONS, AMENDMENTS,  
ADDITIONS, DELETIONS, AND EXCEPTIONS, AND THE 2025 EDITION OF THE CALIFORNIA  
WILDLAND-URBAN INTERFACE CODE**

On Tuesday, June 23, 2026, on motion of Supervisor \_\_\_\_\_, duly seconded by Supervisor \_\_\_\_\_ and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, on May 19, 2026 (Item No. 101), the Board of Directors of the San Bernardino County Fire Protection District adopted Ordinance No. FPD 26-02, which repeals Ordinance No. FPD 23-01 and adopts and amends the 2025 California Fire Code and 2025 California Wildland-Urban Interface Code. A copy of San Bernardino County Fire Protection District Ordinance No. FPD 26-02 is attached to this resolution and incorporated by reference.

WHEREAS, the San Bernardino County Fire Protection District adopted findings in Ordinance No. FPD 26-02, which set forth that the adoption of the Ordinance is reasonably necessary because of local climatic, geological, and topographical conditions. The findings were adopted in accordance with Health and Safety Code section 13869.7.

WHEREAS, in accordance with Health and Safety Code section 13869.7, the Board of Supervisors may ratify, modify or deny the San Bernardino County Fire Protection District Ordinance No. FPD 26-02.

WHEREAS, upon ratification of Ordinance No. FPD 26-02, the County shall submit within 15 days a copy of this resolution and San Bernardino County Fire Protection District Ordinance No. FPD 26-02 with the findings set forth in Ordinance No. FPD 26-02, to the California Department of Housing and Community Development.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors:

1. The above recitals are true and correct.
2. The San Bernardino County Fire Protection District Ordinance No. FPD 26-02 is ratified.
