IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 2
To County Contract No. 11-424

Recitals

WHEREAS, San Bernardino County (COUNTY) and the City of Hesperia (CITY) entered into County Contract No. 11-424 on June 28, 2011, and Amendment No. 1 on March 24, 2020 (hereinafter referred to as "Agreement") to participate in and fund the construction of a road widening project on Ranchero Road, east of Mariposa Road to 7th Avenue, in the Hesperia area (hereinafter referred to as "PROJECT"); and,

WHEREAS, the Agreement expires on August 30, 2024; and

WHEREAS, COUNTY and CITY, hereinafter are also referred to as "Party" and collectively as "Parties", desire to amend the Agreement to extend the contract term by three (3) years, for a new term of June 28, 2011, to August 30, 2027, to complete the PROJECT close out phase and submit the final billing; and,

WHEREAS, PROJECT construction is anticipated to be completed in the summer of 2024; and,

NOW, THEREFORE, in consideration of the mutual covenants and conditions provided herein, the Parties hereto agree that County Contract No. 11-424, as previously amended by Amendment No. 1, is amended a second time as follows:

- 1. DELETE the existing paragraph 3.16 and REPLACE it with a revised paragraph 3.16, which shall read as follows:
 - 3.16 This Agreement and any Amendments hereto may be signed in counterparts, each of which shall constitute an original. The Parties shall be entitled to sign and transmit an electronic signature of the Agreement (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the Party whose name is contained therein. Each Party providing an electronic signature agrees to promptly execute and deliver to the other Party an original signed Agreement upon request.
- 2. DELETE the existing paragraph 25 of the Amendment No. 1 and REPLACE it with a revised paragraph 25, which shall read as follows:
 - 25. This Amendment No. 2 to the Agreement, County Contract No. 11-424, is effective on the date it is approved and signed by both Parties and shall conclude upon satisfaction of the terms identified in paragraph 3.9 of the Agreement or on August 30, 2027 (whichever occurs first).
- 3. The recitals of this Amendment No. 2 are incorporated into the Agreement by reference.
- 4. All other terms and conditions of County Contract No. 11-424 shall remain in effect.
