AMENDMENT No. 3

Contract No 21-514 to provide law enforcement service in the form of three Deputy Sheriffs, acting as School Resource Officers to the Colton Joint Unified School District is hereby amended, effective July 1, 2024 as follows: (1) by replacing the first sentence of Section V. TERM AND TERMINATION, with the sentence below to change the contract end date from June 30, 2024 to June 30, 2025; and (2) to replace the Schedule A referred to in Sections I.A and II.A with the Schedule A attached hereto and incorporated herein by this reference.

V. TERM AND TERMINATION
