I am writing in opposition to the Maverik "fueling station" and convenience store project proposed for Oasis Road and Highway 138 in Pinon Hills. This is not a small gas station. It is "a facility that provides convenience services primarily for the trucking industry." (from the SB County Code.) In other words, a truck stop. We have a gas station one-third of a mile from the proposed site. We have a two convenience stores within that distance. We do not need or want to add traffic congestion, noise, fumes, bright lights, trash, and crime to our quiet, rural, desert-mountain community.

My concerns are (check all that apply):

- Student safety on Oasis Road by the elementary school and at bus stops
- *Crime – we do not have local law enforcement or even a fire station
- Traffic congestion making it difficult for first responders to reach victims
- Traffic congestion making it difficult for postal patrons to safely access the Post Office
- Trucks driving on local, unsuitable roads
- Noise pollution 24 hours a day
- Light pollution at night affecting our Dark Sky community
- Fumes from idling trucks impacting air quality for children and seniors
- Pollution from fuel tracking and underground fuel storage tanks
- The loss of over one-thousand protected Joshua trees
- Incomplete or changing environmental and design reviews
- undesired resultant support allowing interloping of business interests from out of state entities who or which have repeatedly exhibited and articulated adversarial attitudes and policies toward our state, and who don't even appreciate or respect California in any shape or form or exhibit any concerns for our residents, byways, community, wildlife or natural features.
- increase in fatalities as is a characteristic on this particular Highway 138

As our elected officials, the Board of Supervisors should be on the side of their constituents rather than the side of an out-of-state corporation. We aren't against commerce, but we want businesses in our area to be mindful of our rural lifestyle, love of our natural environment, and our beautiful views. We want locally owned businesses that care about Pinon Hills and provide goods and services that we need, not a big, loud, out-of-place corporate business that caters to drive-by traffic.
