

RESOLUTION NO. 2024-59

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-22 (TWIN PEAKS), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-22, therefore, hereby finds and determines:

(a) That on July 16, 2002, the electors of County Service Area 70, Zone R-22, duly authorized a special tax levy for financing road maintenance services.

(b) That the amount of such tax was established at a not to exceed amount of \$217 per parcel for the first year, and \$100 per parcel each year thereafter.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-22, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$100 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.

ATTACHMENT F

Adopt Resolution setting a special tax for 10 parcels annexed to County Service Area 70, Zone R-22 (Twin Peaks) at \$100 per annexed parcel.

Background: County Service Area 70, Zone R-22 (Twin Peaks) was formed on August 21, 1989, with an annual service charge of \$100 per parcel. Currently, there are 178 parcels subject to the service charge. The total revenue for this area is estimated to be \$17,800.

On July 16, 2002, the electorate of the annexation area of County Service Area 70, Zone R-22 (Twin Peaks) authorized a special tax for road maintenance and snow removal service for 14 parcels of land with first year special tax of \$217 per parcel of land and \$100 per parcel thereafter was approved. Currently, due to parcel mergers, there are 10 parcels of land in the annexation area subject to the special tax. The projected revenue from the annexed parcels for FY 2024-25 is \$1,000. The tax is anticipated to generate approximately \$18,700 in FY 2024-25, in relation to estimated total proposed appropriations of \$21,850.

Funds generated by the special tax are used for road maintenance, asphalt patching and snow removal.
