WITNESSETH:

IN THAT CERTAIN **Contract No. 18-385** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Comprehensive Treatment Services: Student Assistance Program (SAP) and School-Aged Treatment Services (SATS), which Contract first became effective July 1, 2018, the following changes are hereby made and agreed to:

- I. ARTICLE V <u>FUNDING</u> and <u>BUDGETARY RESTRICTIONS</u>, paragraph I is hereby amended to read as follows:
 - I. The contract amendment amount of \$3,150,382 shall increase the total contract amount from \$55,379,724 to \$58,530,106 for the contract term.
- II. ARTICLE XIII DURATION and TERMINATION, paragraph A is hereby amended to read as follows:
 - A. The term of this Agreement shall be from July 1, 2018 through March 31, 2025 inclusive.
