AMENDMENT NO. 1 Assignment and Consent to Assignment

WHEREAS, on March 28, 2023, San Bernardino County (“County”) and 21 Tech, LLC entered into an agreement whereby Assignor agreed to provide professional information technology staffing services for a period from March 28, 2023, through March 27, 2028 (“Contract”); and
