2020-21 Proposed Rates Fleet Management Department

The Fleet Management (Fleet) budget unit (791-4064) is an internal service fund (ISF) and all operational costs are financed through Board-approved rates. Fleet has two types of rates: Garage and Motor Pool. The Garage Division provides fuel, maintenance, repair, fabrication, generator, lock-up services, and emergency field services for the majority of the County's fleet of vehicles and heavy equipment. The Motor Pool Division provides vehicles/equipment to departments (essentially a car rental/lease operation).

Garage Division

For 2020-21, Fleet is proposing increases in Light Duty service rates from \$91/hour to \$105/hour and Heavy Duty service rates from \$111/hour to \$121/hour, and various Lock-up service rates primarily due to increases in Salaries and Benefits costs related to MOU increases as well as Services and Supplies costs for garage shop operations. The fuel markup rate for Disaster tanks is recommended to increase from \$0.44 to \$0.47 per gallon, Non-Disaster fuel tank rates from \$2.83 to \$4.69 per gallon, and charges to external entities from \$0.44 to \$0.47 per gallon. The markup rate increase for Non-Disaster fuel tanks is mainly due to an increase in fuel throughput and related direct labor costs.

Garage rates are projected to result in a net revenue increase of \$2.3 million primarily due to increased light and heavy duty shop rates, as well as a projected increase in fuel usage and its subsequent revenue collection.

Motor Pool Division

Fleet's Motor Pool Division has ownership and/or maintenance responsibility for approximately 2,100 automobiles, vans, pickup trucks and various specialty vehicles/equipment assigned to or used by County departments. The Motor Pool coordinates collection and distribution of vehicle replacement funds, fuel, maintenance, administrative and other operational costs.

Motor Pool rates are projected to result in a net revenue increase of \$1.9 million primarily due to changes in the variable rate resulting from the overall cost increases in Garage labor, parts, and higher fuel costs, and changes to fixed rate costs as a result of and vehicle replacements.
