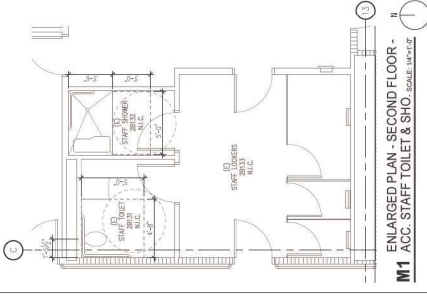
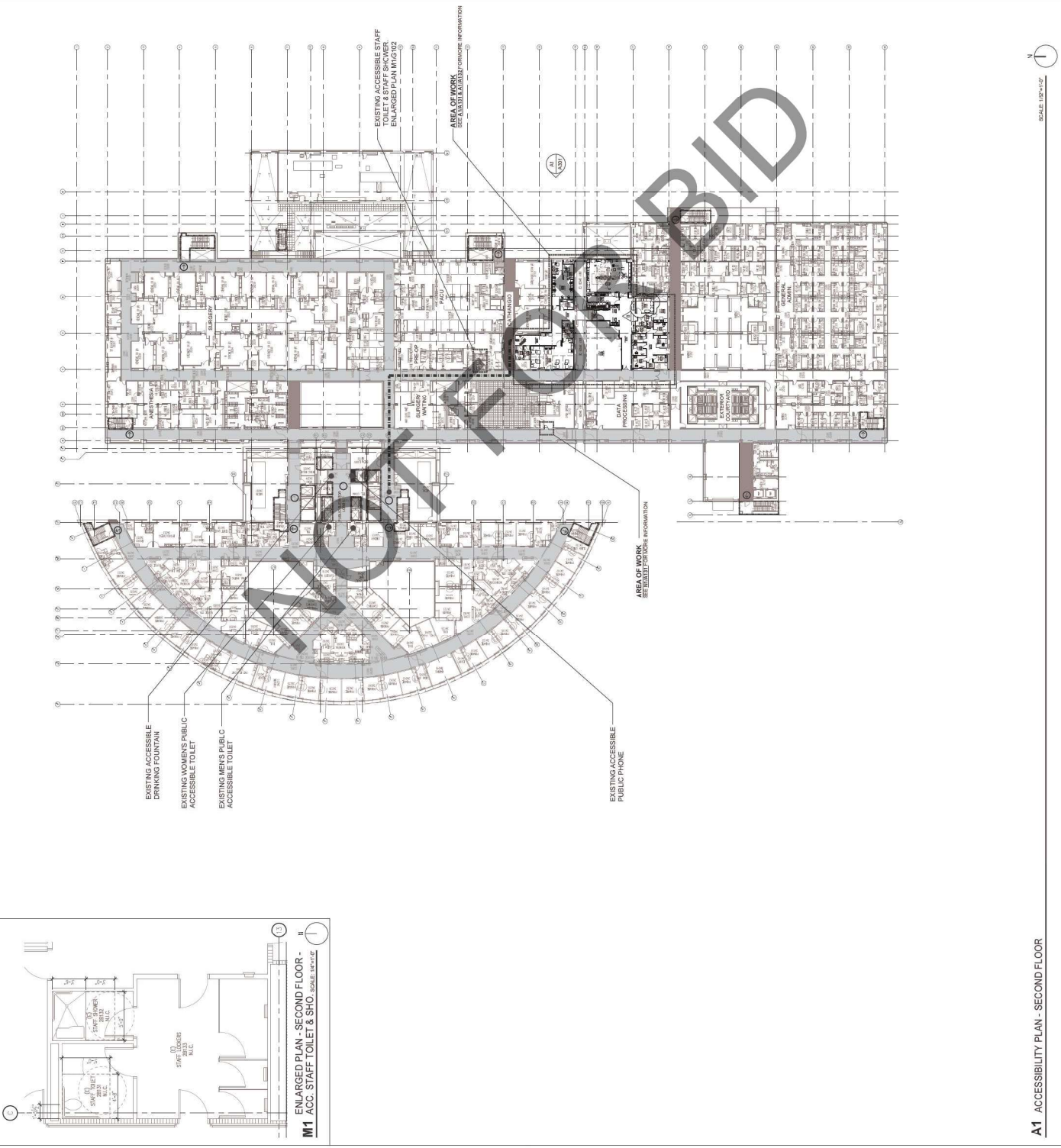
A1 ACCESSIBILITY PLAN - FIRST FLOOR

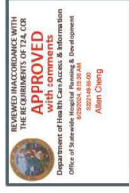

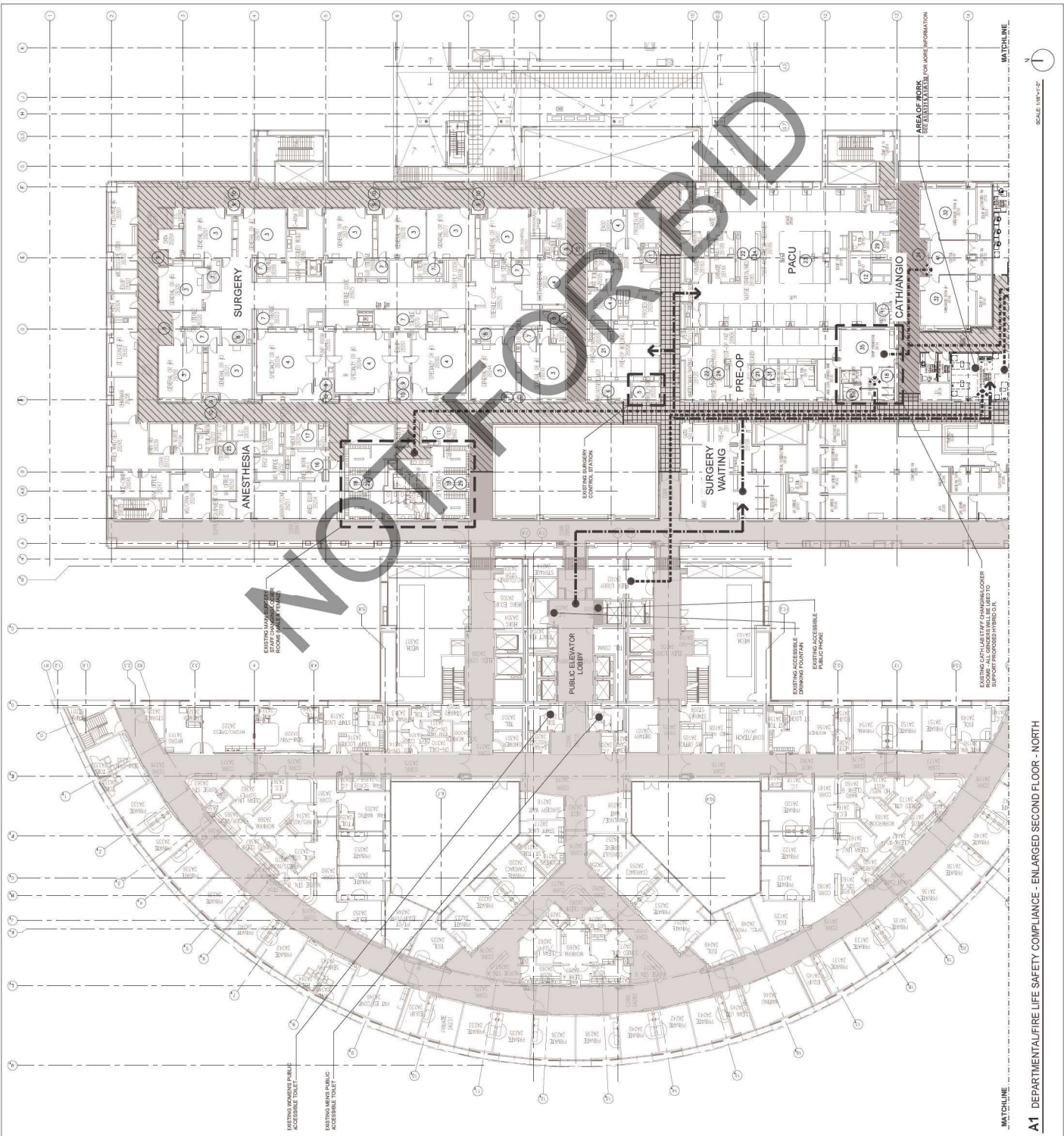

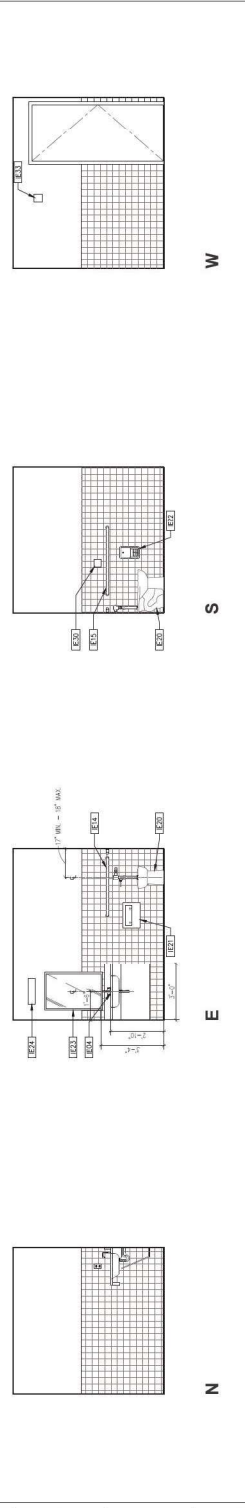

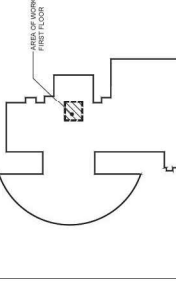
