San Bernardino County Land Use Services - Code Enforcement anticipates that participation in CalRecycle's grant programs, the County will mark improvement with respect to illegal waste tire dumping activities. In addition to scheduled facility and compliance inspections, we will provide educational outreach and enforcement efforts throughout the county to promote the proper transport, storing and disposal of waste tires, thereby reducing the incidences of illegal dumping, improper stockpiling and illegal transport activities.
