### IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 1 TO CONTRACT No. 24-565  
COURT APPOINTED ADULT REPRESENTATION SERVICES FOR INDIGENT DEFENDANTS

**WHEREAS**, on June 25, 2024 (Item No. 50), San Bernardino County (County) entered into Contract No. 24-565 (Contract) with Brown, White & Osborn LLP (Contractor) to provide court appointed adult indigent defense legal representation services in the East Valley and East Desert regions for cases filed in the Superior Court of California, County of San Bernardino, for the period July 1, 2024, to June 30, 2027; and

**WHEREAS**, the County desires to amend the Contract effective July 1, 2024, to adjust the Contract to include additional billing codes.

**NOW, THEREFORE**, the County and Contractor mutually agree to amend the Contract as set forth below:

1. Section E, Fiscal Provisions, Paragraph 5 of the Contract is amended to add the following to the paragraph:

**E.5** Additional billing codes are added to the Contract and the Contractor agrees to receive payment based on the flat fees for services as specified below.

- This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
