AMENDMENT NO. 2

San Bernardino County (County) and Tetra Tech, Inc. (Contractor) hereby agree to amend Contract No. 18-144 as follows:

ARTICLE 4. COMPENSATION, Section 4.1 is amended to read:

The maximum amount of payment under this Contract shall not exceed \$12,336,174.99. The Deputy Director is authorized to move funds between the tasks identified in the Contract, but the total payments under this Contract shall not ~~exceed~~ exceed \$12,336,174.99. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. Compensation payments shall be per Attachments B-1 through B-6, Rate Schedule, for the term of this Contract.
