#### **AMENDMENT NO. 1**

San Bernardino County ("County") and Ramon Salamat ("Contractor") agree to amend the employment contract, Contract No. 22-75 ("Contact"), effective February 12, 2025, as follows:

### 1. SECTION III. TERM is amended to read as follows:

This Contract shall be effective February 12, 2022, and shall remain in effect through February 11, 2026, subject to the termination provisions below. The Assistant Executive Officer of Department Operations is authorized to execute amendments to the Contract to extend the term of the Contract for a maximum of two (2) successive one (1) year periods.
