1 of Voters will keep affected department heads informed of employees who volunteer for
2 service on Election Day in terms of their attendance.

3 (d) The Registrar of Voters will reimburse each employee's department for the
4 compensation the employee receives while in election worker training. Regardless of
5 whether the hours worked as an Election Worker on or before Election Day count as
6 overtime, the Registrar of Voters will reimburse an employee's department for any weekly
7 overtime that the department is liable for due to the employee working as an Election
8 Worker on Election Day.

11 SECTION 2. The Board of Directors declares that it would have adopted this
12 ordinance and each section, sentence, clause, phrase, or portion of it irrespective of the
13 fact that any one or more sections, subsections, clauses, phrases or portions of it be
14 declared invalid or unconstitutional. If for any reason any portion of this ordinance is
15 declared invalid or unconstitutional, then all other provisions of it shall remain valid and
16 enforceable.

18 SECTION 3. This ordinance shall take effect thirty (30) days from the date of
19 adoption.
