RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO TERMINATE ROAD MAINTENANCE OF ROSE AVENUE, BIRCH STREET AND STALLION LANE IN THE BLOOMINGTON AREA

On August 6, 2024, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, Section 954.5(a) of the Streets and Highways Code, provides that the Board of Supervisors of San Bernardino County (Board) may, by resolution, terminate the maintenance of any county highway if it finds that the highway is unnecessary for the public convenience; and,

WHEREAS, Section 954.5(b) of the Streets and Highways Code allows the Board to terminate maintenance of any County highway unnecessary for public convenience after hearing evidence at a public hearing; and,

WHEREAS, a public hearing was conducted on the above described date to consider evidence that the following roads, in the Bloomington area, are unnecessary for the public convenience:

- Rose Avenue (Road Number 708100050) east of Locust Avenue for 0.12 miles;
- Birch Street (Road Number 168600020) north of Rose Avenue for 0.06 miles; and
- Stallion Lane (Road Number 770775010) west of Linden Avenue for 0.19 miles.

NOW THEREFORE, BE IT RESOLVED, that the Board of Supervisors of San Bernardino County finds and determines that all of the recitals contained hereinabove are true and correct and based on the evidence presented Rose Avenue (Road Number 708100050) east of Locust Avenue for 0.12 miles; Birch Street (Road Number 168600020) north of Rose Avenue for 0.06 miles; and Stallion Lane (Road Number 770775010) west of Linden Avenue for 0.19 miles, in the Bloomington area, are unnecessary for public convenience because these roads will no longer provide access to the occupied properties due to the development of the Bloomington Business Park Specific Plan, an industrial business park for approximately 213 acres in the community of Bloomington.

BE IT FURTHER RESOLVED, by the Board of Supervisors of San Bernardino County, that the highway listed below shall no longer be maintained by the County and is hereby deleted from the County Maintained Road System:
