AMENDMENT NO. 1 to CONTRACT No. 23-1138

WHEREAS, on October 23, 2023 (Item No. 61) the Board of Supervisors approved Contract No. 23-1138 with Bergman KPRS, LLC (Contractor) in the amount of \$1,369,878 for the development of the Glen Helen Regional Park Master Plan for the period of November 1, 2023 – December 31, 2024.

The parties hereby agree to retroactively amend Contract No. 23-1138 to extend the contract term from December 31, 2024 to June 2, 2025 as follows:

NOW, THEREFORE, in consideration of mutual covenants and conditions, the parties hereto mutually agree to retroactively amend Contract No. 23-1138 as follows:

Effective December 31, 2024, Contract No. 23-1138 is hereby amended as follows:

1. Replace Section D of the Contract in its entirety with the following:
 - D. This Contract is effective as of November 1, 2023, and expires June 2, 2025, but may be terminated earlier in accordance with provisions of this Contract. The Contract term may be extended for one additional one-year period by mutual agreement of the parties.

All other terms and conditions of the Contract, as amended, shall remain in full force and effect as written.

ELECTRONIC SIGNATURES This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
