ADDENDUM NO. 6 TO THE GLOBAL 2 US BOX ONLY CONTRACT

WHEREAS, on December 5, 2020, San Bernardino County (fka County of San Bernardino) on behalf of Arrowhead Regional Medical Center (County) and Avante Health Solutions fka Global Medical Imaging, LLC (Avante) entered into a Global 2 US Box Only Contract (Contract) with a five year term for the preventative maintenance service and repair (collectively, Service) of certain specified equipment at Arrowhead Regional Medical Center (ARMC); and

WHEREAS, on May 4, 2021, August 23, 2022, May 1, 2023, and July 11, 2024, the parties entered into Addendum No. 1, Addendum No. 2, Addendum No. 3, and Addendum No. 4, respectively, to add additional equipment for Service under the Contract for the remainder of the term of the Contract;

WHEREAS, on March 25, 2025, the parties entered into Addendum No. 5 to the Contract to increase the contract amount to an amount not to exceed \$814,218 to account for repair services and parts; and

WHEREAS, the parties now desire to extend the term of the Contract and increase the contract amount to account for the associated costs; and

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein, and for other good and valuable consideration set forth below, the Contract is amended as follows, effective as of the date this Addendum is fully executed:

1. **Contract Amount.** Total payments under the Contract shall not exceed \$987,428.
2. **Contract Expiration Date:** The Contract expiration date shall be extended to December 4, 2026.
3. **Scope of Work:** The services to be provided by Avante and the equipment for which the services are to be provided under the Contract from December 5, 2025 through December 4, 2026 are set forth on Exhibit A to this Addendum.
4. **Full Force and Effect.** All other terms and conditions of the Contract remain in full force and effect.
5. **Capitalized Terms.** Any capitalized term used but not defined in this Addendum shall have the meaning given to it in the Contract.
6. **Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439)**

Avante has disclosed to the County using Exhibit B – Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), whether it has made any campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Addendum was approved by the County Board of Supervisors. Avante acknowledges that under California Government Code section 84308, Avante is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Addendum.

In the event of a further proposed addendum to the Contract, Avante will provide the County a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed addendum.

Campaign contributions include those made by any agent/person/entity on behalf of the Contractor or by a parent, subsidiary or otherwise related business entity of Contractor.

7. **Counterparts.** This Addendum may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Addendum. The parties shall be entitled to sign and transmit an electronic signature of this Addendum (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Addendum upon request.

EXHIBIT B

Levine Act –

Campaign Contribution Disclosure

(formerly referred to as Senate Bill 1439)

The following is a list of items that are not covered by the Levine Act. A Campaign Contribution Disclosure Form will not be required for the following:

- Contracts that are competitively bid and awarded as required by law or County policy
- Contracts with labor unions regarding employee salaries and benefits
- Personal employment contracts
- Contracts under \$50,000
- Contracts where no party receives financial compensation
- Contracts between two or more public agencies
- The review or renewal of development agreements unless there is a material modification or amendment to the agreement
- The review or renewal of competitively bid contracts unless there is a material modification or amendment to the agreement that is worth more than 10% of the value of the contract or \$50,000, whichever is less
- Any modification or amendment to a matter listed above, except for competitively bid contracts.

DEFINITIONS

Actively supporting or opposing the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

Parent-Subsidiary Relationship: A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
