

RESOLUTION NO. 2025-156

**RESOLUTION OF THE BOARD OF DIRECTORS OF THE BIG BEAR VALLEY RECREATION AND
PARK DISTRICT, ESTABLISHING THE FISCAL YEAR 2025-26 ANNUAL APPROPRIATIONS
LIMIT**

On Tuesday, June 10, 2025, on motion of Director Baca, Jr., duly seconded by Director Hagman and carried, the following resolution is adopted by the Board of Directors of the Big Bear Valley Recreation and Park District.

WHEREAS, Article XIII B of the California State Constitution imposes a limitation on appropriations by local governmental entities; and

WHEREAS, adoption of a resolution establishing appropriations limit for the Big Bear Valley Recreation and Park District for the upcoming fiscal year is required by Government Code Section 7910; and

WHEREAS, Proposition 111, as adopted by the voters on June 5, 1990, changed the manner of calculating the appropriations limit under Article XIII B of the California State Constitution; and

WHEREAS, Section 1 of Article XIII B of the California Constitution generally provides that the total annual appropriations subject to limitation of the State and of each local government shall not exceed the appropriations limit of the entity of government for the prior year adjusted for the change in the cost of living and the change in population; and

WHEREAS, in determining "change in the cost of living" pursuant to Section 8(e)(2) of Article XIII B of the California State Constitution, an entity of local government other than a school district or a community college district has the option to select either (A) the percentage change in California per capita personal income from the preceding year, or (B) the percentage change in the local assessment roll from the preceding year due to the addition of local non-residential new construction; and

WHEREAS, the appropriations limit in Attachment "A" represent the limit based on Option (A) the percentage change in California per capita personal income from the preceding year as this is the only information available at this time;

NOW, THEREFORE, BE IT RESOLVED, the Board of Directors of the Big Bear Valley Recreation and Park District hereby finds, determines, declares, and resolves as follows:

Section 1. All of the above recitals are true and correct.

Section 2. Fiscal year 2025-26 appropriations limit for the Big Bear Valley Recreation and Park District are established as set forth in the Annual Appropriations Limits report attached hereto.

Section 3. This resolution shall take effect upon its adoption.

BE IT FURTHER RESOLVED that said Attachment "A" presents the fiscal year 2025-26 annual appropriations limit now adopted by the Board of Directors.
