

RESOLUTION NO. 2020-144

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO,
STATE OF CALIFORNIA, AUTHORIZING ITS AGENTS TO ACT ON BEHALF OF SAN
BERNARDINO COUNTY FOR ALL MATTERS PERTAINING TO STATE AND FEDERAL
DISASTER ASSISTANCE TO THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY
SERVICES AND THE U.S. DEPARTMENT OF HOMELAND SECURITY'S FEDERAL EMERGENCY
MANAGEMENT AGENCY**

On Tuesday, July 14, 2020, on motion of Supervisor Lovingood, duly seconded by Supervisor Gonzales and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Governor of the State of California and/or the President of the United States can declare state and federal disasters for purposes of assisting with reimbursements through the California Governor's Office of Emergency Services (Cal OES) and the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA); and

WHEREAS, this action designates the Chief Executive Officer, County Chief Financial Officer, Deputy Executive Officer, Auditor-Controller/Treasurer/Tax Collector, Assistant Auditor-Controller/Treasurer/Tax Collector, Auditor-Controller/Treasurer/Tax Collector Division Chief, Auditor-Controller/Treasurer/Tax Collector Manager, Sheriff/Coroner/Public Administrator, Undersheriff, and Sheriff's Captain – Bureau of Administration as authorized agents to execute this application for and on behalf of the County of San Bernardino, a public entity established under the laws of the State of California, and to file it with Cal OES for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act;

NOW THEREFORE, BE IT RESOLVED THAT, the County of San Bernardino, a public entity established under the laws of the State of California, hereby authorizes the Chief Executive Officer, , County Chief Financial Officer, Deputy Executive Officer, Auditor-Controller/Treasurer/Tax Collector, Assistant Auditor-Controller/Treasurer/Tax Collector, Auditor-Controller/Treasurer/Tax Collector Division Chief, Auditor-Controller/Treasurer/Tax Collector Manager, Sheriff/Coroner/Public Administrator, Undersheriff, and Sheriff's Captain – Bureau of Administration to provide to Cal OES and FEMA executed applications and related documents as necessary for all matters pertaining to such state and/or federal disaster assistance and agreements required. This is a universal resolution and is effective for all open and future disasters up to three years following the date of resolution adoption.
