

RESOLUTION NO. 2024-67

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-46 (SOUTH FAIRWAY DRIVE), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-46, therefore, hereby finds and determines:

(a) That on August 10, 2010, the electors of County Service Area 70, Zone R-46, duly authorized a special tax levy for road paving and road maintenance services.

(b) That the amount of such tax shall be a first year special tax of \$4,775 per parcel and \$325 per parcel each year thereafter with an annual 2.5% inflationary factor increase for road paving and road maintenance services.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-46, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$437.10 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.

Adopt Resolution setting a special tax for County Service Area 70, Zone R-46 (South Fairway Drive) in the Lake Arrowhead area at \$437.10 per parcel, which includes the annual 2.5% inflationary factor increase.

Background: On August 10, 2010, the electorate of County Service Area 70, Zone R-46 (South Fairway Drive) authorized the levy and collection of a first year special tax of \$4,775 per parcel, and \$325 per parcel each year thereafter with a 2.5% inflationary factor for road paving and road maintenance services. Based on 18 parcels, the tax will generate \$7,868 for FY 2024-25, in relation to estimated total proposed appropriations of \$8,900.

Funds generated by the special tax will fund road maintenance and snow removal services.
