

RESOLUTION NO. 2023-162

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, ZONE R-9 (RIM FOREST), REPEALING PORTIONS OF RESOLUTION NO. 83-192 AND AUTHORIZING AN INCREASED PROPERTY RELATED SERVICE CHARGE FOR ROAD MAINTENANCE AND SNOW REMOVAL SERVICES

On Tuesday, August 22, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, Zone R-9 (Rim Forest), hereby finds and determines:

- a) A mailed ballot election, pursuant to Proposition 218 and Cal. Const. art. XIII D, § 6(c), of property owners within County Service Area 70, Zone R-9 (Rim Forest) regarding the proposed increase to property related service charge from \$60 per parcel to \$194.40 per parcel per year for ongoing operating and maintenance costs (with an annual inflationary increase of up to 3%) and \$307.09 per parcel per year for a 10-year period to fund repayment of a loan, with interest, for a road paving project, for a total of \$501.49 per parcel per year, effective Fiscal Year 2023-24, for road maintenance and snow removal services.
- b) The election date of June 9, 2023, or any day thereafter, was established as date for the mailed ballot election, for vote by the property owners within County Service Area 70, Zone R-9 (Rim Forest), with the election conducted by an independent election service provider.
- c) Ballots were mailed by an independent election provider on April 26, 2023, were returned and received by the election date of June 9, 2023, and the proposed increased property related service charge was approved by a majority vote of the property owners of the property subject to the service charge.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

- a) The Board hereby adopts the certified election results for the proposed increased property related service charge, which was approved by a majority vote of the property owners of the property subject to the service charge.
- b) That pursuant to property owner approval, there is hereby established an annual service charge of \$501.49 per parcel, per year, (with an annual inflationary increase of up to 3%), effective Fiscal Year 2023-24 on real property within the boundaries of the District and said service charge shall be collected on the tax bills for the affected properties beginning in FY 2023-24, subject to Board of Equalization approval.
- c) That those portions of Resolution No. 83-192 initially establishing an annual property related service charge of \$60 per parcel for road maintenance and snow removal services is hereby repealed.
- d) The Clerk of the Board is hereby directed to certify the passage of this resolution and to file copies of same and a map or plat indicating the boundaries of the affected territory with the County Assessor and the State Board of Equalization; the Clerk is further directed to request the recordation of this resolution in the official records of San Bernardino County

and to forward copies of this resolution and the map or plat to the following: The Registrar of Voters of the County of San Bernardino, the Surveyor of the County of San Bernardino, and the Auditor of the County of San Bernardino; the Clerk is further directed to file an appropriate Notice of Exemption in connection therewith.
