AMENDMENT No. 2

Contract No. 20-512 is being amended, effective June 25, 2024 as follows:

- By replacing section D. TERM OF CONTRACT, in its entirety, and replacing it with a new section D. TERM OF CONTRACT, as follows:

D. TERM OF CONTRACT

This Contract is effective July 1, 2020 through June 30, 2025, but may be terminated earlier in accordance with provisions of this Contract.

The County and the Superintendent each reserve the right to terminate the Contract, for any reason, with a thirty (30) day written notice of termination. Such termination may include all or part of the services described herein. Upon such termination, and if arrangements for a fee-for-service amendment is agreed to by the parties according to sections F.3 and F.4, payment will be made to the Superintendent for services rendered and expenses reasonably incurred prior to the effective date of termination. Upon receipt of a termination notice, Superintendent shall promptly discontinue services unless the notice directs otherwise. Superintendent shall deliver promptly to County and transfer title (if necessary) to all completed work, and work in progress, including drafts, documents, plans, forms, data, products, graphics, computer programs, and reports.

Except as amended, all other terms and conditions of the Contract remain as stated therein.
