#### LOCALLY NEGOTIATED AGREEMENT

This Locally Negotiated Agreement ("Agreement") is entered into by and between Covidien Sales LLC, a Medtronic company, at 60 Middletown Avenue, North Haven, CT 06473 ('Seller" or "Medtronic"), and San Bernardino County on behalf of Arrowhead Regional Medical Center at 400 N Pepper Avenue, Colton, CA 92324 ("Customer"). The term "Customer" as used herein includes Customer's Participating Facilities (as defined below).

- 1. <u>Definitions</u> As used in this Agreement, the following terms shall have the meanings specified below:
  - a. "Product Categories" means the product categories listed on below, as applicable which list may be updated from time to time.
    - (i) "Endomechanical Products" means the products listed on Exhibit A.
    - (ii) "Trocar Products" means the products listed on Exhibit A.
    - (iii) "Electrosurgery Products" means the products listed on Exhibit A.
    - (iv) "Vessel Sealing Products" means the products listed on Exhibit A.
    - (v) "Smoke Evacuation Products" means the products listed on Exhibit A.
  - b. "Products" means the Endomechanical Products, Trocar Products, Electrosurgery Products, Vessel Sealing Products, and Smoke Evacuation Products, collectively.
- c. "Net Purchases" means the total purchase price actually paid by Customer for Products purchased pursuant to this Agreement, net of products provided at no charge, returns, allowances, credits, rebates, taxes, freight and insurance. To the extent Customer purchases products through an Authorized Distributor, the Net Purchases of such products will be based on the Net Purchase price paid by the Authorized Distributor to Seller and will not include any mark-up charged by the Authorized Distributor to Customer.
- d. "Pre-Participation Net Purchases" means the total purchase price actually paid by Customer to Medtronic for Products purchased during the 12 months immediately preceding Customer's first contract year on this Agreement, net of free products, recalls, rejection, returns, allowances, credits, refunds, taxes, freight and insurance, and fees, rebates and/or other payments made by Seller to distributors in connection with such purchases.
- e. "Contract Year" means the 12-month period commencing upon the first day of the term of this Agreement and each consecutive succeeding 12-month period during the Term of this Agreement.

#### 2. Commitments

At least (i) 85% of Customer's endomechanical product purchases and trocar product purchases (measured in the aggregate across all Customer facilities, in dollars, on an annualized basis) will be Seller's Endomechanical Products and Trocar Products, (ii) 90% of Customer's electrosurgery product purchases (measured in the aggregate across all Customer facilities, in dollars, on an annualized basis) will be Seller's Electrosurgery Products, and (iii) 90% of Customer's vessel sealing product purchases and smoke evacuation product purchases (measured in the aggregate across all Customer facilities, in dollars, on an annualized basis) will be Seller's Vessel Sealing Products and Smoke Evacuation Products. The "endomechanical product purchases", "trocar product purchases", "electrosurgery product purchases", "vessel sealing product purchases" and "smoke evacuation product purchases" includes any new or reprocessed products from third party vendors, or any stapling/energy options offered by third party vendors manufacturing robotic assisted technologies. For purposes of this section of the Agreement, "Customer's facilities" refers only to Arrowhead Regional Medical Center and not to any other

department, unit, or facility of San Bernardino County. If Customer does not meet the compliance or commitments requirements set forth above for a particular Product Category that is required to receive pricing in that Product Category, Customer will not receive the pricing for such applicable Product Category but will not be subject to any penalties or price increases because of such non-compliance hereunder with regard to any other Product Category under this Agreement. Customer must complete the Seller compliance form ("Compliance Form") attached hereto as Attachment B, following the conclusion of each six-month period occurring during the Term of this Agreement, or at such other times as Seller may reasonably require. Customer must complete and return the Compliance Form to Seller within thirty (30) days of Customer's receipt of such Compliance Form from Seller, sent by Seller to Customer as part of Customer's compliance review. Seller and Customer will review such completed Compliance Form within thirty (30) days following Seller's receipt thereof. In the event that Seller determines in good faith that Customer is not trending towards compliance with its commitment, Seller may terminate this Agreement and revoke pricing hereunder, and place Customer at the GPO tier for which they would qualify upon at least thirty (30) days prior written notice to Customer.

#### 3. Pricing

The pricing set forth on Exhibit A attached hereto shall apply through the Term of this Agreement, unless Seller determines in good faith that Customer is not trending towards its compliance commitments set forth above. Notwithstanding the foregoing or any other provision of this Agreement to the contrary, Seller reserves the right (i) to add new Products to this Agreement, from time to time, and (ii) to delete one or more specific Seller Products from the scope of this Agreement at any time, without prior notice to Customer, insofar as Seller discontinues its manufacture or sale of the same within the United States. All prices hereunder shall apply solely to Participating Facilities' purchase of Products pursuant to this Agreement directly from Seller. Seller does not control resale prices or resale terms applicable to the sale of Products by Seller-authorized distributors. Accordingly, Participating Facilities shall negotiate such resale price and terms directly with any Seller-authorized distributor through which Participating Facility may elect to purchase the Products.

#### 4. Participating Facilities

Exhibit B identifies the facilities (including Customer) who may participate under this Agreement (the "Participating Facilities"). All orders from Participating Facilities will be subject to the terms and conditions of this Agreement. Customer will provide Seller written notice if it wishes to add a new facility to this Agreement and such facility will be added unless Seller notifies Customer that such facility will not be added. Customer represents and warrants that it either owns, has controlling interest in, or has express contractual authority to make purchasing decisions on behalf of each Participating Facility, including those added as set forth herein, if any.

#### 5. **Term and Termination**

The term of this Agreement (the "Term") is for three (3) years, unless terminated earlier, and if Customer is purchasing direct from Seller, will begin as upon the first day of the next month following the date of full execution by both duly authorized parties. Either party may terminate this Agreement on thirty (30) days' prior written notice to the other party. Customer's ARMC Chief Executive Officer is authorized to terminate this Agreement on behalf of Customer.

#### 6. Purchase Method

Pricing under this Agreement is available for direct purchase from Seller. For those Products that Seller makes available through distributors, Customer may purchase such Products direct from Seller or from Seller's authorized distributors and Seller will make Customer's Product pricing available to Customer's choice of authorized distributors provided that Customer has notified Seller of its choice of authorized distributor(s) through Seller's then-current process for designating distributors. Customer must notify Seller at least twelve (12) business days prior to adding or changing distributors. Any service fees or markups on the Products charged by the distributor are to be negotiated between Customer and such distributor, and Seller will not reimburse or be responsible for such fees or mark-ups. Seller's freight terms, returned goods policies and payment terms do not apply to purchases from authorized distributors—the terms applicable to such purchases must be negotiated between Customer and the authorized distributor.

The rebates set forth herein are in lieu of and replace, any and all rebates set forth in any other agreement with regard to such products purchased by Customer and its Participating Facilities. The rebate requirements are set forth in <u>Attachment A</u>. For the avoidance of doubt, any equipment/hardware products listed on <u>Exhibit A</u> are excluded from rebate calculations herein.

- a. <u>Payment of Rebates</u> Within ninety (90) days following the last day of the applicable Contract Year Medtronic will calculate the rebates and pay any earned rebate to the Customer. Payment will be in the form of an electronic funds transfer ("EFT"). Customer shall complete an EFT enrollment form supplied by Medtronic upon request. Medtronic agrees to review any issues relating to the rebate provided they are brought to Medtronic's attention within sixty (60) days following Customer's receipt of the affected rebate payment. A ny such issue not brought to Medtronic's attention during such sixty (60) day period shall be deemed waived by Customer and its Participating Facilities.
- b. Additional Requirements Upon request of Customer, Medtronic may conduct business reviews with the Customer on a quarterly basis. A quarterly report of Customer's actual purchases or acquisitions and Net Purchases for any product type under <a href="Exhibit A">Exhibit A</a> will be available upon request from Medtronic. Notwithstanding any other provisions of this Agreement, Medtronic reserves the right to withhold payment of any earned rebate (in whole or in part) if the Customer (i) is not in compliance with the terms of this Agreement, (ii) is not in good credit standing as reasonably determined by Medtronic's Accounts Receivable Department, or (iii) has not paid any invoice for any purchase giving rise to such rebate.

#### 8. Treatment of Rebates/Treatment of Price Reductions

Customer understands that this sale involves a discount or reduction in price. Unless specified otherwise, any rebates will be calculated on the price then in effect. Customer agrees to provide information sufficient to properly disclose and reflect this discount in costs claimed or charges made to federal health care programs in accordance with the provisions of 42 U.S.C. § 1320a-7b(b)(3)(A) and/or 42 C.F.R. §1001.952(h)(1) and any other relevant federal and state health care rules and regulations. To the extent necessary, Medtronic shall assist Customer in complying with any requirements requested relating to any applicable discounts or reductions in price on each Customer invoice, to enable Customer to comply with its reporting obligations.

#### 9. Other Terms and Conditions

If Customer has designated a group purchasing organization ("GPO") as its primary GPO under Seller's processes and Seller has entered into a contract with the GPO for purchases of the Products (each a "GPO Contract"), then purchases of such Products will be subject to the terms of the applicable GPO Contract, except as otherwise set forth in this Agreement. Customer has currently designated Vizient Supply, LLC as its primary GPO. If there is a conflict between the GPO Contract and a term in this Agreement, the term of this Agreement will control. Upon expiration or termination of the applicable GPO Contract, (i) if Seller is awarded a follow-on agreement by the GPO or its successor with respect to such Products (a "GPO Follow-on Agreement"), then this Agreement shall continue subject to the terms and conditions of such GPO Follow-on Agreement, or (ii) if Seller is not awarded a GPO Follow-on Agreement for a particular Product category, Seller and Customer agree to negotiate in good faith to enter into a mutually agreeable custom pricing agreement incorporating the pricing and Products set forth herein ("Custom Agreement") and, until such time as the parties have entered into the Custom Agreement, the terms and conditions of the GPO Agreement relating solely to Seller and Customer (but not those terms relating to the GPO including, without limitation, payment of administrative fees) and this Agreement shall continue to govern Customer's purchase of Products as if such GPO Contract had not expired. If the parties are unable to reach an agreement on the terms and condition of the Custom Agreement within ninety (90) days of the expiration of the GPO Contract, this Agreement and the pricing hereunder will expire.

#### 10. LIMITATION OF LIABILITY

EXCEPT FOR INDEMNIFICATION OBLIGATIONS UNDER THE GPO CONTRACT OR OTHERWISE, ANY CLAIMS BASED ON GROSS NEGLIGENCE, VIOLATIONS OF LAW, OR WILFUL MISCONDUCT, IN NO EVENT SHALL EITHER PARTY BE LIABLE

TO THE OTHER PARTY FOR REPROCUREMENT COSTS, LOST PROFITS, LOSS OF USE, OR INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, EVEN IF PARTY HAS BEEN ADVISED OF THE POSSIBILITY THEREOF, ARISING OUT OF OR IN CONNECTION WITH THE SALE, DELIVERY, INSTALLATION, USE, LOSS OF USE, REPAIR OR PERFORMANCE OF THE PRODUCTS, INCLUDING ALL ADDITIONS TO AND REPLACEMENTS OF THE PRODUCTS, OR ANY FAILURE OR DELAY IN CONNECTION WITH ANY OF THE FOREGOING. THIS SECTION DOES NOT PRECLUDE ANY LIABILITY WHICH, UNDER APPLICABLE PRODUCTS LIABILITY LAW, CANNOT LEGALLY BE PRECLUDED BY CONTRACT.

#### 11. Compliance with Laws

The parties agree to comply with all applicable laws, including, without limitation, those governing Medicare/Medicaid reporting obligations. If this Agreement involves a discount or reduction in price, Customer must properly disclose and reflect such discount in costs claimed or charges made to federal health care programs in accordance with the provisions of 42 U.S.C. § 1320a-7b(b)(3)(A) and/or 42 C.F.R. §1001.952(h)(1) and any other relevant federal and state health care rules and regulations. If pricing or other terms in under this Agreement are materially altered by reason of such law, governmental decree, regulation, order or action, Seller will have the right at its sole discretion to (a) immediately terminate this Agreement by written notice to Customer; (b) suspend deliveries for the duration of such restriction or alteration; or (c) have applied to this Agreement (as of the effective date of such restriction or alteration) any prices or other terms governmentally acceptable.

#### 12. Software License

Seller may provide software ("Software") in connection with the Products. Such Software is licensed and not sold. All Software delivered by Seller, whether such Software is provided with the Product or separately, is governed by the terms of Seller's Software License which can be furnished upon request.

#### 13. Debarment and Suspension

Medtronic hereby represents and warrants that it is currently not convicted of any criminal offense related to health care nor has been debarred, excluded, or otherwise ineligible for participation in any federal or state government health care program, including Medicare and Medicaid. Further, Medtronic represents and warrants that no proceedings or investigations are currently pending or to Medtronic's knowledge threatened by any federal or state agency seeking to exclude Medtronic from such programs or to sanction Medtronic for any violation of any rule or regulation of such programs.

#### 14. Insurance

Seller shall comply with the insurance requirements set forth on Exhibit D, the terms of which are incorporated herein by this reference.

#### 15. Governing Law/Venue

This Agreement shall be governed by and construed under the laws of the State of California. The parties acknowledge and agree that this Agreement was entered into and intended to be performed in California. Venue of any action or claim brought by any party to this Agreement will be in the state or federal courts of California.

#### 16. Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439)

To the extent applicable by law, and limited to Medtronic plc ("Medtronic") (including Covidien Sales LLC) and its Chief Executive Officer, and to the best of their actual knowledge, has disclosed to the Customer using Exhibit E—Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), whether it has made any campaign contributions of more than \$500 to any member of the San Bernardino County ("County) Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the 12 months before the date this Agreement was approved by the Board of Supervisors. Medtronic acknowledges that under California Government Code section 84308, Medtronic is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Agreement.

In the event of a proposed amendment to this Agreement, Medtronic will provide the County a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment. The prohibition and disclosure obligation applies to those individuals or entities as specified in California Government Code Section 84308.

#### 17. Miscellaneous

This Agreement, including all referenced Exhibits, is the entire understanding and agreement between the parties concerning the subject matter of this Agreement, and supersedes all prior negotiations, agreements and understandings between the parties, whether oral or in writing, concerning the subject matter of this Agreement. Customer understands that the pricing, set forth herein, is confidential and agrees not to disclose the pricing to any other party without the written consent of Seller. Notwithstanding the foregoing, Customer may disclose the terms of this Agreement where required by law, including, but not limited to the Ralph Brown Act or the California Public Records Act, or to its third party business and legal advisors having a need to know such information to properly perform their respective obligations to Customer under this Agreement; provided, however, that any such third party advisors agree to (a) maintain such information in strict confidence, (b) use such information only to perform their respective obligations, and (c) not further disclose such information to any third party. Customer shall be responsible for any improper disclosure of such information by such third party advisors. Covidien acknowledges that Customer is a public entity under California law and that, pursuant to the Ralph Brown Act, this Agreement will be made public as part of the approval process with the San Bernardino County Board of Supervisors, and that such disclosure is not a violation of this provision of the Agreement.

18. This Agreement may only be amended in writing signed by authorized representatives of both parties. If any provision of this Agreement is held to be illegal, invalid or unenforceable, the legality, validity and enforceability of the remaining provisions will not be altered or impaired. In such event, the parties will use commercially reasonable efforts to replace the invalid or unenforceable provision. Except for payment of monies due, this Agreement may not be assigned by either party without the consent of the other party, except that either party may assign this Agreement to an affiliate or to a purchaser of the assignor's business or the business unit to which this Agreement relates provided, however, in the case of such assignment by Customer, assignment is only allowed to an assignee with reasonable credit standing. Notwithstanding the foregoing, in the event that Medtronic assigns this Agreement to an affiliate or to a purchaser of Medtronic's business or the business unit to which this Agreement relates, Medtronic must promptly provide written notice of such assignment to Customer and to the extent the assignee is an entity with whom Customer is legally prohibited from doing business, Customer may terminate the Agreement upon written notice. The failure of either party to enforce at any time or for any period of time any term of this Agreement will not be a waiver of such provision nor of the right of Seller or Customer, as the case may be, thereafter to enforce each and every such provision. Any alterations made by Customer to this Agreement are null and void. Each person signing this Agreement represents and warrants that he or she is duly authorized to execute this Agreement on behalf of the party for which it is signing. This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

### Attachment A Rebate Requirements

- a) New Business Rebate. Provided that Customer has met (i) the annual revenue commitment of at least \$275,000.00 in Net Purchases of Endomechanical Products and Trocar Products and (ii) the annual revenue commitment of at least \$300,000.00 in Net Purchases of Electrosurgery Products, Vessel Sealing Products, Ultrasonic Cutting Products and Smoke Evacuation Products during the first contract year and has been in compliance with the terms and conditions of this Agreement, a new business rebate will be paid at the end of the first contract year of the Agreement. The amount of such new business rebate shall equal fifteen (15%) percent of the amount, if any, by which Customer's Net Purchases of Products during its first contract year on this Agreement exceed such Customer's Pre-Participation Net Purchases of Products. For avoidance of doubt this New Business Rebate is for the first contract year only if earned.
- b) All Product Rebate For Endomechanical and Trocar Products. Provided that during each contract year(s) of the Term of this Agreement, Customer has achieved an annual revenue commitment of at least \$ 275,000.00 in Net Purchases of Endomechanical Products and Trocar Products and has been in compliance with the other terms and conditions hereof, Medtronic shall pay an All Product Rebate equal to three (3%) percent of Customer's Net Purchases of Endomechanical Products and Trocar Products made during such contract year and pursuant to this Agreement. For avoidance of doubt this All Product Rebate is for the Endomechanical Products and Trocars Products only and no other products will count towards this rebate calculation.
- c) All Product Rebate For Surgical Energy Products. Provided that during each of the second contract year, and third contract year(s) of the Term of this Agreement, Customer has achieved an annual revenue commitment of at least \$300,000.00 in Net Purchases of Electrosurgery Products, Ultrasonic Cutting Products, Vessel Sealing Products and Smoke Evacuation Products and has been in compliance with the other terms and conditions hereof, Medtronic shall pay an All Product Rebate equal to three (3%) percent of Customer's Net Purchases of Electrosurgery Products, Ultrasonic Cutting Products, Vessel Sealing Products and Smoke Evacuation Products made during such contract year and pursuant to this Agreement. For avoidance of doubt this All Product Rebate is for the second contract year and third contract year only if earned, and for Electrosurgery Products, Ultrasonic Cutting Products, Vessel Sealing Products and Smoke Evacuation Products and no other Products will count towards this rebate calculation.

### Exhibit D Insurance Requirements

Seller agrees to provide insurance set forth in accordance with the requirements herein. If Seller uses existing coverage to comply with these requirements and that coverage does not meet the specified requirements, Seller agrees to amend, supplement or endorse the existing coverage to do so.

- 1. Without in anyway affecting any indemnity obligations provided and in addition thereto, Seller shall secure and maintain throughout the contract term the following types of insurance with limits as shown:
  - a. Workers' Compensation/Employer's Liability A program of Workers' Compensation insurance or a state-approved, self-insurance program in an amount and form to meet all applicable requirements of the Labor Code of the State of California, including Employer's Liability with \$250,000 limits covering all persons including volunteers providing services on behalf of Seller and all risks to such persons under this contract. If Seller has no employees, it may certify or warrant to Customer that it does not current ly have any employees or individuals who are defined as "employees" under the Labor Code and the requirement for Workers' Compensation coverage will be waived by Customer's Director of Risk Management. With respect to contractors that are non-profit corporations organized under California or Federal law, volunteers for such entities are required to be covered by Workers' Compensation insurance.
  - b. <u>Commercial/General Liability Insurance</u> –Seller shall carry General Liability Insurance covering all operations performed by or on behalf of Seller providing coverage for bodily injury and property damage with a combined single limit of not less than one million dollars (\$1,000,000), per occurrence. The policy coverage shall include:
    - i. Premises operations and mobile equipment.
    - ii. Products and completed operations.
    - iii. Broad form property damage (including completed operations).
    - iv. Explosion, collapse and underground hazards.
    - v. Personal injury.
    - vi. Contractual liability.
    - vii. \$2,000,000 general aggregate limit.
  - c. <u>Automobile Liability Insurance</u> —Primary insurance coverage shall be written on ISO Business Auto coverage form for all owned, hired and non-owned automobiles or symbol 1 (any auto). The policy shall have a combined single limit of not less than one million dollars (\$1,000,000) for bodily injury and property damage, per occurrence. If Seller is transporting one or more non-employee passengers in performance of contract services, the automobile liability policy shall have a combined single limit of two million dollars (\$2,000,000) for bodily injury and property damage per occurrence. If Seller owns no autos, a non-owned auto endorsement to the General Liability policy described above is acceptable.
  - d. <u>Professional Liability</u> –Professional Liability Insurance with limits of not less than one million (\$1,000,000) per claim and two million (\$2,000,000) aggregate limits

or

<u>Errors and Omissions Liability Insurance</u> -Errors and Omissions Liability Insurance with limits of not less than one million (\$1,000,000) and two million (\$2,000,000) aggregate limits

If insurance coverage is provided on a "claims made" policy, the "retroactive date" shall be shown and must be before the date of the start of the contract work. The claims made insurance shall be maintained or "tail" coverage provided for a minimum of five (5) years after contract completion.

- e. <u>Cyber Liability Insurance</u> Cyber Liability Insurance with limits of no less than \$1,000,000 for each occurrence or event with an annual aggregate of \$2,000,000 covering privacy violations, information theft, damage to or destruction of electronic information, intentional and/or unintentional release of private information, alteration of electronic information, extortion and network security. The policy shall protect the involved Customer and cover breach response cost as well as regulatory fines and penalties.
- 2. Additional Insured. All policies, except for Worker's Compensation, Errors and Omissions and Professional Liability policies shall contain additional endorsements naming Customer and its officers, employees, agents and volunteers as additional named insured with respect to liabilities arising out of the performance of services hereunder. The additional insured endorsements shall not limit the scope of coverage for Customer to vicarious liability but shall allow coverage for Customer to the full extent provided by the policy. Such additional insured coverage shall be at least as broad as Additional Insured (Form B) endorsement form ISO, CG 2010.11 85.
- 3. Waiver of Subrogation Rights. Seller shall require the carriers of required coverages to waive all rights of subrogation against Customer, its officers, employees, agents, volunteers, contractors and subcontractors. All general or auto liability insurance coverage provided shall not prohibit Seller and Seller's employees or agents from waiving the right of subrogation prior to a loss or claim. Seller hereby waives all rights of subrogation against Customer.
- 4. **Policies Primary and Non-Contributory**. All policies required herein are to be primary and non-contributory with any insurance or self-insurance programs carried or administered by Customer.
- 5. **Severability of Interests**. Seller agrees to ensure that coverage provided to meet these requirements is applicable separately to each insured and there will be no cross liability exclusions that preclude coverage for suits between Seller and Customer or between Customer and any other insured or additional insured under the policy.

- 6. **Proof of Coverage**. Seller shall furnish Certificates of Insurance to Arrowhead Regional Medical Center evidencing the insurance coverage at the time the Contract is executed, additional endorsements, as required shall be provided prior to the commencement of performance of services hereunder, which certificates shall provide that such insurance shall not be terminated or expire without thirty (30) days written notice to Arrowhead Regional Medical Center, and Seller shall maintain such insurance from the time Seller commences performance of services hereunder until the completion of such services. Within fifteen (15) days of the commencement of this contract, Seller shall furnish a copy of the Declaration page for all applicable policies and will provide complete certified copies of the policies and endorsements immediately upon request.
- 7. **Acceptability of Insurance Carrier**. Unless otherwise approved by Risk Management, insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best" Insurance Guide rating of "A- VII".
- 8. **Deductibles and Self-Insured Retention**. Any and all deductibles or self-insured retentions in excess of \$10,000 shall be declared to and approved by Risk Management.
- 9. Failure to Procure Coverage. In the event that any policy of insurance required under this contract does not comply with the requirements, is not procured, or is canceled and not replaced, Customer has the right but not the obligation or duty to cancel the contract or obtain insurance if it deems necessary and any premiums paid by Customer will be promptly reimbursed by Seller or Customer payments to Seller will be reduced to pay for Customer purchased insurance.
- 10. Insurance Review. Insurance requirements are subject to periodic review by Customer. The Customer's Director of Risk Management or designee is authorized, but not required, to reduce, waive or suspend any insurance requirements whenever Risk Management determines that any of the required insurance is not available, is unreasonably priced, or is not needed to protect the interests of Customer. In addition, if the Department of Risk Management determines that heretofore unreasonably priced or unavailable types of insurance coverage or coverage limits become reasonably priced or available, the Director of Risk Management or designee is authorized, but not required, to change the above insurance requirements to require additional types of insurance coverage or higher coverage limits, provided that any such change is reasonable in light of past claims against Customer, inflation, or any other item reasonably related to Customer's risk. Any change requiring additional types of insurance coverage or higher coverage limits must be made by amendment to this contract. Seller agrees to execute any such amendment within thirty (30) days of receipt. Any failure, actual or alleged, on the part of Customer to monitor or enforce compliance with any of the insurance and indemnification requirements will not be deemed as a waiver of any rights on the part of Customer.

# LEVINE Act – CAMPAIGN CONTRIBUTION DISCLOSURE

(formerly referred to as Senate Bill 1439)

The following is a list of items that are not covered by the Levine Act. A Campaign Contribution Disclosure Form will not be required for the following:

- Contracts that are competitively bid and awarded as required by law or County policy
- Contracts with labor unions regarding employee salaries and benefits
- Personal employment contracts
- Contracts under \$50,000
- Contracts where no party receives financial compensation
- Contracts between two or more public agencies
- The review or renewal of development agreements unless there is a material modification or amendment to the agreement
- The review or renewal of competitively bid contracts unless there is a material modification or amendment to the agreement that is worth more than 10% of the value of the contract or \$50,000, whichever is less
- Any modification or amendment to a matter listed above, except for competitively bid contracts.

#### **DEFINITIONS**

Actively supporting or opposing the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
