AMENDMENT NO. 4

WHEREAS, San Bernardino County on behalf of Arrowhead Regional Medical Center (“Customer”) and Howmedica Osteonics Corp., acting through its Orthopaedics Division, Wright Medical Technology, Inc. and Tornier, Inc. (both affiliates of Howmedica Osteonics Corp., and collectively, “Stryker”) entered into a Product Pricing Agreement (“Agreement”) dated January 5, 2024; and

WHEREAS, the parties have amended the Agreement on three prior occasions; and

WHEREAS, the parties desire to further amend the Agreement to increase the contract amount; and

NOW THEREFORE, effective as of the date this Amendment is fully executed, the parties agree that the Agreement is amended as follows:

1. The last sentence of Section 3 “Purchase Orders; Invoices; Payments” of the Standard Terms and Conditions of the Agreement is deleted and replaced with the following:

“The total amount of purchase under this Agreement shall not exceed \$3,450,000 without an amendment to this Agreement, executed by both parties, increasing the dollar amount.”

- 2. **Full Force and Effect.** The Agreement, as amended by this Amendment, remains in full force and effect.
- 3. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Agreement, as applicable.
- 4. **Counterparts.** This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same agreement. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
- 5. In the event of a conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall prevail.
