

## RESOLUTION NO. 2022-44

### **RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACTING AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, DECLARING INTENTION TO FORM A NEW ZONE, COUNTY SERVICE AREA 70, ZONE R-50 (MERCURY WAY), FOR ROAD PAVING, MAINTENANCE, AND SNOW REMOVAL SERVICES**

On Tuesday, March 15, 2022, on motion of Supervisor Baca, duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, hereby finds and determines:

a) That County Service Area 70, was formed on November 13, 1969, allowing for the creation of new zones in the unincorporated area of San Bernardino County.

b) That this Board desires to form a new zone to be known as County Service Area 70, Zone R-50 (Mercury Way), pursuant to Government Code section 25217 et seq.

c) That the exterior boundaries of the territory proposed to be formed into the said zone are described and set forth in Exhibit "A," attached hereto and incorporated herein by this reference.

d) That staff was contacted by residents along Mercury Way, Crestline, for the reasons of a desire to form a new road district zone comprised of approximately 1,800 linear feet of paved road and that would provide road services to include pulverizing of existing road surface and repaving, maintenance, and snow removal on Mercury Way between the intersections of Skyland Drive to the North and South in Crestline.

e) That County Service Area 70, Zone R-50 (Mercury Way), is intended for the purpose and reasons of providing road services, including road paving, maintenance, and snow removal services.

f) That staff is recommending that a public hearing and election be conducted to determine if the property owners would be in favor of approving a property related service charge in the amount of \$632.65 per parcel, upon California State Board of Equalization. The proposed service charge includes debt service of \$422.68 for ten years and operation and maintenance cost of \$209.97 per parcel (with an annual inflationary increase of up to 3%).

g) That staff recommends to this Board that said Zone R-50 (Mercury Way), of County Service Area 70, be formed if this Board determines at the close of the public hearing scheduled for May 10, 2022, that a majority protest does not exist and if the election in favor of approving a property related service charge is successful.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

a) That this Board declares the intention to form County Service Area 70, Zone R-50 (Mercury Way).

b) That a public hearing shall be held at 10:00 a.m. on Tuesday, May 10, 2022, in the Chambers of the Board of Supervisors, County Government Center, 1st Floor, 385 North Arrowhead Avenue, San Bernardino, California, to consider the formation of County Service Area 70, Zone R-50 (Mercury Way).

c) That a public hearing shall be held at 10:00 a.m. on Tuesday, May 10, 2022, in the Chambers of the Board of Supervisors, County Government Center, 1st Floor, 385 North Arrowhead Avenue, San Bernardino, California, to consider the approval of a property related service charge in the amount of \$632.65 per parcel to provide the necessary financing for the road services.

d) That the Clerk of this Board shall publish a notice of the hearing pursuant to Section 6061 of the Government Code in a newspaper of general circulation within the county.

e) That the Clerk of this Board shall mail notice of the hearing to all property owners within County Service Area 70, Zone R-50 (Mercury Way), and to each city and special district which contains, or whose sphere of influence contains County Service Area 70, Zone R-50 (Mercury Way), at least twenty (20) days before the hearing.

f) That the Clerk of the Board shall post notice of the hearing in at least three (3) public places within County Service Area 70, Zone R-50 (Mercury Way)

g) That at said hearing, the testimony of all interested parties for or against the formation County Service Area 70, Zone R-50 (Mercury Way), and for or against approval of a property related service charge in the amount of \$632.65 per parcel to provide the necessary financing for the road services, will be heard.
