

**RESOLUTION NO. 2026-38**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY  
TO ESTABLISH A “NO STOPPING, STANDING OR PARKING ZONE” ON VARIOUS STREETS  
WITHIN THE SPEEDWAY COMMERCE CENTER II AREA, IN THE FONTANA AREA**

On Tuesday April 21, 2026, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works – Special Districts reviewed and approved a traffic engineering investigation prepared by Albert A. Webb Associates, dated January 21, 2026, and certified by a licensed Traffic Engineer in accordance with the California Manual on Uniform Traffic Control Devices, evaluating certain roadways within the Speedway Commerce Center II area, in the Fontana area; and

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on Special District roads pursuant to County Code 52.0118(a); and,

WHEREAS, based upon the traffic engineering investigation, the Board of Supervisors finds it appropriate to establish parking restrictions along specified roadways within the Speedway Commerce Center II area to in order to facilitate the movement of traffic, eliminate hazardous conditions, and regulate the flow of traffic.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- 1) Due to conditions affecting the welfare of the public utilizing Jeff Gordon Drive, Jimmy Johnson Drive, Dreamland Drive, Sunset Drive and France Family Drive within the Speedway Commerce Center area, in the Fontana area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:
  - a. Establish a “No Stopping, Standing or Parking Zone,” pursuant to County Code Section 52.0118(a), along the entire length of the south side of each of the following roadways within the Speedway Commerce Center II area, in the Fontana area:
    - i. Jimmie Johnson Drive
    - ii. Jeff Gordon Drive
    - iii. Dreamland Drive
    - iv. Sunset Drive
    - v. France Family Road
- 2) The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
